RESOLUTION NO. 92-20

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA APPROVING TRANSFER OF CERTAIN PROPERTY KNOWN AS HOLLY AVENUE, THIRD STREET, AND FOURTH STREET, MORE FULLY DESCRIBED BELOW, TO THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR CONSTRUCTION OF A STATE ROAD AND BRIDGE.

WHEREAS, the Florida Department of Transportation proposes to construct an improved State Road AlA, Section 78030-2546 in St. Johns County, Florida; and

WHEREAS, it is necessary that certain lands now owned by St. Johns County be acquired by the State of Florida for the use and benefit of the Florida Department of Transportation; and

WHEREAS, said property is not needed for County purposes;

whereas, the Florida Department of Transportation has made application to St. Johns County to execute and deliver to the Florida Department of Transportation a county deed in favor of the State of Florida, conveying all rights, title and interest, including all mineral rights, that St. Johns County has in and to the lands described in Exhibit A attached hereto and made a part hereof, which lands are required for right-of-way for the above-described state road and which lands will be transferred without reservation of mineral rights pursuant to the Florida Department of Transportation's request that such mineral rights be released by the County, and said requests having been duly considered:

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County as follows:

Section 1. The application of the Florida Department of Transportation for a county deed is for right-of-way purposes which are in the public or community interest and for the public welfare, and the land needed for right-of-way and other road purposes is not needed for County purposes.

Section 2. A county deed in favor of the Florida Department of Transportation conveying all right, title and interest of St. Johns County, without warranty of title or warranty of method of conveyance, in and to the lands described in the attached Exhibit A required for right-of-way and other road purposes shall be executed by the Chairman or Vice Chairman of the Board of County Commissioners. Consideration shall be \$10.00. A copy of the proposed deed is attached to this resolution as Exhibit B.

Section 3. Florida Department of Transportation has requested, pursuant to 270.11(3), Fla. Stat. (1991), that the County release the mineral rights in the property described in Exhibit A. The request has been duly considered and granted by the Board of County Commissioners because the property at issue is to be used for construction of a bridge and for road right-of-way; therefore, all mineral rights in the subject property are hereby released.

Section 4. A certified copy of this resolution shall be forwarded forthwith to the Florida Department of Transportation at Tallahassee, Florida.

Section 5. A copy of the county deed transferring the property described in Exhibit B to the Florida Department of Transportation shall be duly recorded in the official public records of St. Johns County, Florida.
