A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA APPROVING THE RECORDING OF RIGHT-OF-WAY MAPS OF COUNTY ROAD 312 EXTENSION CONVEYING TO THE FLORIDA DEPARTMENT OF TRANSPORTATION ALL RIGHT, TITLE, AND INTEREST OF ST. JOHNS COUNTY IN THE ROAD, STREET, HIGHWAY, SET FORTH ON THE RIGHT- OF WAY MAPS; AUTHORIZING TRANSFER OF ST. JOHNS WATER MANAGEMENT DISTRICT PERMIT NO.42-109-0272AIGM TO THE FLORIDA DEPARTMENT OF TRANSPORTATION; AND PROVIDING

FOR RECORDING OF RIGHT-OF-WAY MAPS OF COUNTY ROAD 312 EXTENSION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION AND TRANSFER OF PERMIT.

WHEREAS, St. Johns County Road 312 Extension was officially added to the State Highway System in accordance with the criteria contained in Section 334.03 (6),(7) and 335.04 of the Fla. Stat.; and

WHEREAS, the Florida Department of Transportation has requested that the Board of County Commissioners of St. Johns County, Florida record the right-of-way maps in order to transfer title of the roadway to the Florida Department of Transportation; and

WHEREAS, The Florida Department of Transportation has also requested that, pursuant to Section 270.11 (3), Fla. Stat.(1991), the County release the mineral rights in the property being transferred as road right-of-way to the Florida Department of Transportation:

NOW ,THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida as follows:

Section 1. The right-of-way maps shall be recorded with the Clerk of Courts of St. Johns County, Florida transferring in accordance with Section 337.29, Fla. Stat (1991) all right, title and interest of St. Johns County, in the road, street, highway, set forth on the maps to the Florida Department of Transportation, County Road 312 from the Southeasterly right-of-way line of State Road No.207 easterly to the west right of way line of U.S. No 1 (State Road No.5).

Section 2. Florida Department of Transportation has requested, pursuant to Section 270.11 (3), Fla. Stat. (1991), that the County release all mineral rights on the property indicated on the road right-of-way maps. The request has been duly considered and granted by the Board because the property is being used for road right-of-way; therefore, all mineral rights on the property indicated on the right-of-way maps are hereby released.

Section 3. The Board of County Commissioners of St. Johns County, Florida hereby authorizes the transfer of St. Johns Water Management District Permit No.42-109-0272AIGM along with its attendant modifications and conditions issued to St. Johns County to the Florida Department of Transportation.

Section 4. The Clerk is instructed to record the right-of-way maps in favor of the Florida Department of Transportation in the official records of St. Johns County at County expense.

Section 5. A certified copy of this resolution along with a copy of the road right-of-way maps shall be forwarded to the Florida Department of Transportation.
