JOHNS, STATE OF FLORIDA, SETTING A HEARING TO CONSIDER THE ADVISABILITY OF VACATING AND DETERMINING WHETHER IT WILL VACATE (1) A PORTION OF HENRY STREET LY-ING IMMEDIATELY SOUTH OF LOTS 1 AND 2, BLOCK 3, ROTHS-CHILDS ADDITION; AND (2) A PORTION OF UNNAMED ALLEY LY-ING IMMEDIATELY NORTH OF LOTS 1 AND 2, BLOCK 3, ROTHS-CHILDS ADDITION, BOTH AS MORE FULLY DESCRIBED BELOW.

is hereby authorized and directed to be published.
Further, notice of the time, date and place of the public
hearing shall be promptly mailed by certified mail, return
receipt requested, to each of the persons and entities at their

, search #, attached to
the Petition to Vacate.
The petitioner shall perform such mailings and shall provide
the Clerk with proof of same five days before the scheduled hear-
ing date.

(1) Re: Portion of Alleyway

That portion of that unnamed 12 foot alley lying immediately north of Lots 1, 2, 3 and 4 (not vacated by BCC Resolution No. 84-96), Block 3, Rothschilds Addition, as per Map Book 3, Page 133, of the public records of St. Johns County, Florida, excepting therefrom that portion of the subject property lying within the right-of-way of S.R. No. 5-A as now established.

(2) Re: Portion of Henry Street

That portion of Henry Street, an unopened subdivision street, which is 50 feet wide, lying immediately south of Lots 1 and 2, Blk. 3, Rothschilds Addition, as per Map Book 3, page 133, of the public records of St. Johns County, Florida, excepting therefrom that portion of the subject property lying within the right-ofway of S.R. No. 5-A as now established.
