RENAMING A STREET  
FROM: BURTS BOULEVARD  
TO: LA PASADA CIRCLE

WHEREAS, an application has been duly made to the board of county commissioners to rename Burts Boulevard;

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners;

WHEREAS, the E-911 Coordinator has reviewed the petition, and recommends that it be granted; and

WHEREAS, it is found to be in the public interest to rename this street as requested in futherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The petition to rename Burts Boulevard is hereby granted.
2. The street name known as Burts Boulevard is hereby renamed to La Pasada Circle and shall hereafter be known by that name.
3. The E-911 Coordinator is instructed to take whatever steps are necessary to change the street name and to notify the Property Appraiser's office of the change.
4. The petitioner shall notify, in writing, all residents on Burts Boulevard affected by this resolution of the name change.
