PRECINCT 1, DISTRICT 5

Beginning at the intersection of County Road 214, also known as King Street, and the west shores of the San Sebastian River; thence westerly along King Street to Mackey Lane; thence southerly along Mackey Lane to South Dixie Highway; thence southerly along South Dixie Highway to Isabel Street; thence westerly along Isabel Street to Hopkins Street; thence southerly along Hopkins Street to Madeore Street; thence westerly along Madeore Street to Sidney Street; thence northerly along Sidney Street to Christopher Street; thence westerly along Christopher Street to the westerly limits of the City of St. Augustine; thence northerly along said city limits to Avery Street; thence easterly along Avery Street to Whitney Street; thence southerly along Whitney Street to Josiah Street; thence easterly along Josiah Street; thence easterly along Helen Street to Florida Avenue; thence southerly; along Florida Avenue to Evergreen Avenue; thence easterly along Evergreen Street to the west shores of the San Sebastian River; thence southerly along the west shores of the San Sebastian River to the point of beginning.

PRECINCT 3, DISTRICT 5

Beginning at the intersection of U.S. #1 and State Road 16; thence southerly along U.S. #1 to Grove Avenue; thence easterly along Grove Avenue to Riberia Street; thence southerly along Riberia Street to Castillo Drive; thence easterly along Castillo Drive to Avenida Menendez; thence easterly along an extension of Castillo Drive to the centerline of the channel of the Matanzas River; thence southerly along the centerline of the Matanzas River to the Bridge of Lions; thence westerly along the Bridge of Lions to Avenida Menendez; thence southerly along Avenida Menendez to King Street; thence westerly along King Street to the centerline of the San Sebastian River; thence northerly along said centerline to State Road 16; thence easterly along State Road 16 to the point of beginning.

PRECINCT 4, DISTRICT 5

Beginning at the intersection of the Bridge of Lions, also known as State Road A1A, and the centerline of the channel of the Matanzas River; thence southerly along said channel of the Matanzas River to where the channel intersects the easterly extension of the mouth of Maria Sanchez Lake; thence westerly and northerly along the centerline of Maria Sanchez Lake to a point where the said centerline intersects South Street; thence westerly along South Street to the western shores of Maria Sanchez Lake; thence northerly along the shores of the Lake to St. Francis Street; thence northerly along St. Francis Street to Cordova Street; thence northerly along Cordova Street to Bridge Street; thence westerly along Bridge Street to Granada Street; thence northerly along Granada Street to Cedar Street; thence westerly along Cedar Street to Central Avenue; thence northerly along Central Avenue to LaQuinta Place; thence westerly along LaQuinta Place to Riberia Street; thence northerly along King Street to Menendez Avenue; thence northerly along Menendez Avenue to where the west end of the Bridge of Lions intersects Cathedral Place; thence easterly along the Bridge of Lions to the point of beginning.

PRECINCT 5, DISTRICT 2

Beginning at a point where the centerline of the channel of the Matanzas River intersects the easterly extension of the mouth of Maria Sanchez Lake; thence southerly along the Matanzas River channel to a point where the centerline of the channel of the San Sebastian River intersects the channel of the Matanzas River; thence westerly and northerly along the centerline of the San Sebastian River to King Street; thence easterly along King Street to Riberia Street; thence southerly along Riberia Street to LaQuinta Place; thence easterly along LaQuinta Place to Central Avenue; thence southerly along Central Avenue to Cedar Street; thence easterly along Cedar Street to Granada Street; thence southerly along Granada Street to Bridge Street; thence easterly along Bridge Street to Cordova Street; thence southerly along Cordova Street to St. Francis Street to Washington Street; to the western shores of Maria Sanchez Lake, thence southerly to the point where the western Lake shores intersect South Street; thence easterly along South Street to the centerline of Maria Sanchez Lake; thence southerly and easterly along said centerline to the point of beginning.

PRECINCT 6, DISTRICT 5

Beginning at the intersection of the westerly extension of the centerline channel of St. Augustine Inlet and the easterly limits of the City of St. Augustine; thence southerly along said easterly limits line and continuing along the west bank of Salt Run to the point where the City limit line turns easterly, which is also the southerly limit line of Anastasia State park; thence easterly along said line to the shores of the Atlantic Ocean; thence southerly along the shores to the city limits of the City of St. Augustine Beach; thence westerly along said city limits to SR AlA, also known as Anastasia Blvd.; thence northerly along Anastasia Blvd. to the Bridge of Lions; thence over the Bridge of Lions to the center line of the channel of the Matanzas River; thence northerly and easterly along said channel to the point of beginning.

PRECINCT 7, DISTRICT 4

Beginning at a point where the centerline of the channel of the Intracoastal Waterway intersects the boundary of St. Johns County and Duval County; thence easterly along the St. Johns County boundary to Ponce de Leon Blvd., also known as State Road AlA; thence southerly along Ponce de Leon Blvd. to southeast corner of Ponte Vedra/Palm Valley School property; thence clockwise around the perimeter of the said school; thence to the westerly right-of-way of Ponce de Leon Blvd.; thence northerly along said right-of-way to Solano Road., also known as State Road 210A; thence westerly along Solano Road to the intersection of State Road 210A and North Roscoe Blvd; thence westerly from said intersection along an extension of State Road 210A to the centerline of the Intracoastal Waterway; thence northerly along the Intracoastal Waterway to the point of beginning.

PRECINCT 8, DISTRICT 4

Beginning at the intersection of the shores of the Atlantic Ocean and the boundary line between St. Johns County and Duval County; thence southerly along the shores of the Atlantic Ocean to the easterly extension of Mickler's Cutoff Road; thence along said extension to the intersection of County Road 203 and Mickler's Cutoff Road; thence northerly along county Road 203 to Corona Road; thence westerly along Corona Road to Ponce de Leon Blvd., also known as State Road AlA; thence northerly along Ponce de Leon Blvd. to the St. Johns County boundary; thence easterly along the St. Johns County boundary to the point of beginning.

PRECINCT 9, DISTRICT 4

Beginning at the intersection of County Road 210 and Canal Blvd.; thence northerly along County Road 210 to Ponce de Leon Blvd, also known as State Road AlA; thence northerly along Ponce de Leon Blvd. to the southeast corner of Ponte Vedra/Palm Valley School property; thence to the southwest corner of said school; thence to the northwest corner of said school; thence easterly to Ponce de Leon Blvd.; thence northerly along Ponce de Leon Blvd. to Solano Road; thence westerly along Solano Road to where it intersects North Roscoe Blvd.; thence westerly along an extension of Solano Road to where it intersects the centerline of the Intracoastal Waterway; thence southerly along the Intracoastal Waterway to where it intersects an extension of Canal Blvd.; thence easterly along said extension to Canal Blvd.; thence easterly along Canal Blvd. to the point of beginning.

PRECINCT 10, DISTRICT 1

Beginning at the intersection of U.S. #1 and Nine Mile Road; thence westerly along Nine Mile Road to I-95; thence southerly along I-95 to SR-16; thence easterly along SR-16 to the west shores of San Sebastian River, said west shores being also the westerly limits of the City of St. Augustine; thence northerly along said west shores of San Sebastian River to the north limits of the City of St. Augustine at the township line between Township 6 and 7 South; thence easterly along said north limits of the City of St. Augustine to U.S. #1; thence northerly along U.S. #1 to the point of beginning.

PRECINCT 11, DISTRICT 1

Beginning at the intersection of I-95 and the South boundary line of Duval County; thence westerly then northerly along said boundary to Durbin Creek; thence westerly along the south bank of Durbin Creek to Julington Creek; thence continuing westerly along the centerline of Julington Creek to County Road 13; thence southerly along County Road 13 to Ida Roberts Road; thence Southeasterly along Ida Roberts Road to where said road intersects a graded road running Easterly and lying approximately along the section line between Section 8 and 17 in Township 5 South, Range 27 East; thence Easterly along said graded road to where the same intersects a graded road running Southerly; thence Southerly and Easterly along said graded road in Section 16, Township 5 South, Range 27 East, to where the same graded road intersects a graded road running Northeasterly; thence Northeasterly along said graded road in Section 15, Township 5 South, Range 27 East, to where the same graded road intersects a graded road running Southerly; thence Southerly along said graded road in Sections 15 and 22, Township 5 South, Range 27 East, to Bombing Range Road, also known as Green Briar Road; thence Easterly along Bombing Range Road to CR-210; thence Easterly along CR-210 to I-95; thence Northerly along I-95 to the point of beginning.

PRECINCT 12, DISTRICT 2

Beginning at the intersection of I-95 and State Road 16; thence southerly along I-95 to County Road 214; thence westerly along County Road 214 to Poa Boy Road; thence northerly along Poa Boy Road to Sawdust Road; thence westerly along Sawdust Road to County Road 13A; thence northerly along county Road 13A to the northerly line of Census Block 150; thence westerly along said line to the centerline of the powerlines which are 8000 feet west of County Road 13A; thence northerly along said powerlines to County Road 208; thence easterly along County Road 208 to County Road 16; thence easterly along County Road 16 to the point of beginning.

PRECINCT 13, DISTRICT 1

Beginning at the intersection of U.S. #1 and the northern boundary between St. Johns County and Duval County; thence easterly along the county boundary to Palm Valley Road, also known as County Road 210; thence northeasterly along Palm Valley Road to where said road intersects the northerly line of section 55, also known as the northerly line of the Miranda Grant; thence easterly along said line to the Intracoastal Waterway; thence southerly along the Intracoastal Waterway to Stokes Creek; thence westerly along Stokes to Stokes Road; thence westerly along Stokes Road; thence westerly along Stokes to Stokes Road; thence westerly along US #1 to Nine Mile Road; thence westerly along Nine Mile Road to I-95; thence northerly along I-95 to Cummer Road; thence easterly along Cummer Road to Taylor Island Road; thence northerly along Taylor Island Road to Cypress Tree Branch Road; thence westerly and northerly along Cypress Tree Branch Road to County Road 210; thence easterly along County Road 210 to U.S. #1; thence northerly along U.S. #1 to the point of beginning.

PRECINCT 14, DISTRICT 4

Beginning at the intersection of I-95 and State Road 206; thence northerly along I-95 to State Road 207; thence westerly along State Road 207 to the census tract line that seperates tracts 132 and 133; thence northerly along said line to the Florida East Coast Railroad; thence southerly along the railroad to State Road 207; thence southerly a short distance along State Road 207 to Solano Pen Road; thence westerly along Solano Pen Road to the easterly line of Census Block 118; thence northerly and westerly along said line, said line also being a part of McCullough Creek to County Road 13A; thence continue westerly along McCullough Creek, said creek now being the line dividing census blocks 227 and 229 to where said line intersects the easterly line of census block 228; thence southerly along said line to a powerline; thence southerly along the powerline to County Road 13; thence easterly along County Road 13 to County Road 305; thence easterly along County Road 13 to County Road 305; thence easterly along County Road 305 to census line diving census blocks 251 and 254; thence southerly and westerly along said line to County Road 13; thence northerly along County Road 13A to St. Ambrose Road; thence easterly along St. Ambrose Road to Masters Road; thence southerly along Masters Road to the census line dividing Census blocks 273 and 274; thence westerly along said line to County Road 13; thence southerly along Masters Road to Manuel Drive; thence easterly along Manuel Drive; thence easterly along Manuel Drive to State Road 207; thence easterly along Masters Road to Manuel Drive; thence easterly along Manuel Drive to State Road 207; thence easterly along Messervey Road; thence northerly along Messervey Road; thence northerly along Messervey Road to County Road 305; thence easterly and northerly Road 305 to State Road 206; thence easterly along State Road 207 to Messervey Road; thence northerly along County Road 305 to State Road 206; thence easterly along State Road 206 to the point of beginning.

PRECINCT 17, DISTRICT 3

Beginning at the intersection of US 1 and the Southerly limits of the City of St. Augustine; thence Easterly and Northeasterly along the Southerly city limits line to the West shores of San Sebastian River, said West shores also being the Southerly limits of said City of St. Augustine; thence Southerly along said West shores of San Sebasitan River and continuing Southeasterly and Northeasterly along the Southerly city limits line to Matanzas River to where said run of Matanzas River intersects Moultrie Creek; thence Westerly along the center of Moultrie Creek to US 1; thence Northerly along US 1 to the point of beginning.

PRECINCT 18, DISTRICT 5

Beginning at the intersection of the shores of the Atlantic Ocean and the southern city limits of St. Augustine Beach; thence westerly along said city limits to State Road AlA; thence northerly along AlA to State Road 3; thence northerly along State Road 3 to Pope Road; thence easterly along Pope Road to limits of the City of St. Augustine; thence northerly and westerly along said city limits to where said city limits intersect the centerline of the Mantanzas River; thence southerly along the Matanzas River to San Julian Creek; thence easterly along San Julian Creek to Dondanville Road; thence easterly along Dondanville Road to the shores of the Atlantic Ocean; thence northerly along the shores to the point of beginning.

PRECINCT 19, DISTRICT 2

Beginning at the intersection of I-95 and State Road 206; thence westerly along State Road 206 to Cowpen Branch Road; thence northerly along said road to where it bends westerly; thence westerly along said road to Beach Road; thence northerly along Beach Road to the northerly line of Census block number 436; thence westerly along said line to State Road 207; thence southerly along State Road 207 to Moore Lane; thence westerly along Moore Lane to the Florida East Coast Railroad; thence westerly along said railroad to Ashland Avenue, said avenue runs parallel to said railroad; thence westerly along Ashland Avenue to Main Street; thence southerly along Main Street to said railroad; thence westerly along said railroad to Campbell Road; thence westerly along Campbell Road to where said road intersects the range line between Ranges 27 and 28 East; thence South on said range line also being the boundary line of Putnam County to a point where the South boundary line of Section 18 in Township 10 South, Range 28 East, intersects said range line; thence East on said section line also being the boundary line of Flagler County and continuing East along said county line to the range line between Ranges 29 and 30 East; thence North on said range line to the middle of Pellicer's Creek; thence Easterly on an imaginary line down the middle of said creek to where said creek intersects I-95; thence Northerly along I-95 to the point of beginning.

PRECINCT 20, DISTRICT 5

Beginning at the intersection of the shores of the Atlantic Ocean and the easterly extension of State Road 206; thence Northerly along the Atlantic coast to a point where the Easterly extension of Dondanville Road intersects said Atlantic coast; thence West along the Easterly extension of Dondanville Road and continuing West along said road to San Julian Creek; thence Southwesterly along the center of San Julian Creek to Matanzas River; thence Southerly along the thread of Matanzas River to State Road 206; thence easterly along State Road 206 to the point of beginning.

PRECINCT 21, DISTRICT 2

Beginning at the intersection of I-95 and County Road 214; thence easterly along County Road 214 to the west line of census tract 257; thence northerly and easterly along said line to Holmes Blvd.; thence northerly along Holmes Blvd. to Thompson Bailey Road; thence westerly along Thompson Bailey Road to Deer Run Drive; thence northerly along Deer Run Drive to Four Mile Road; thence southeasterly along Four Mile Road to Ervin Street; thence easterly along Ervin Street to Volusia Avenue; thence northerly along Volusia Avenue to Ravenswood Drive; thence easterly along Ravenswood Drive to Allen Street; thence southerly along San Pedro Avenue to Rodriquez Street; thence southerly along Rodriquez Street to Evergreen Street; thence easterly along Evergreen St. to Francis Street; thence northerly along Francis Street to Helen Street; thence northwesterly from the intersection of Francis and Helen Street; thence northerly along Oakes Avenue; thence northerly along Oakes Avenue; thence northerly along Oakes Avenue to Josiah Street; thence easterly along Josiah Street to Francis Street; thence northerly along Francis Street to Avery Street; thence easterly along Avery Street to the western limits of the City of St. Augustine; thence southerly along said limits to John Street; thence westerly along John Street to

Rodriquez Street; thence southerly along Rodriquez Street to Madeore Street; thence westerly along Madeore Street to Nassau Street; thence southerly along a dirt road, said dirt road also being an extension of Nassau Street; thence westerly along said dirt road until it bears northerly; thence northerly along said dirt road to an easterly extension of 15th Street; thence westerly along said extension to the intersection of Brevard Street and 15th Street; thence westerly along 15th Street to Clay Street; thence northerly along Clay Street to Collier Blvd.; thence westerly along Collier Blvd. to Holmes Blvd.; thence northerly along Holmes Blvd. to the Florida East Coast Railway; thence southwesterly along said railway to I-95; thence northerly along I-95 to the point of beginning.

PRECINCT 22, DISTRICT 1

PRECINCT 24, DISTRICT 5

Beginning at the intersection of the South line of Pope Road, said South line of Pope Road also being the North limits of the City of St. Augustine Beach; and the West right-of-way line of State Road 3; thence southerly along the west right-of-way line of State Road AlA, said west right-of-way line of State Road 3 and State Road AlA being also the West limits of the City of St. Augustine Beach, to the South limits of said City of St. Augustine Beach; thence easterly along the south limits of the City of St. Augustine Beach, said south limits being also the north line of St. Augustine By The Sea, to the shores of the Atlantic Ocean; thence northerly along the shores of the Atlantic Ocean to where said shores intersects the South line of Pope Road; thence westerly along the south line of Pope Road; thence westerly along the south line of Pope Road to the point of beginning.

PRECINCT 25, DISTRICT 3

Beginning at the intersection of US 1 and Moultrie Creek; thence southerly along US 1 to the most northerly entrance of Shores Blvd.; thence northeasterly along Shores Blvd. to Deltona Blvd.; thence southeasterly along Deltona Blvd. to.
