RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE EXECUTION OF A CERTAIN AGREEMENT ACCEPTING THE DONATION OF A PORTION OF PROPERTY NECESSARY FOR IMPROVEMENTS AT THE INTERSECTION OF STATE ROAD 312 AND COUNTY ROAD 5-A.

WHEREAS, Brianne L. Sinha desires to donate a portion of her property to the County, more fully described in the Agreement which is attached hereto as Exhibit A, incorporated by reference and made a part hereof; and

WHEREAS, it is in the best interest of the citizens of Johns County to acquire ownership of the Property necessary for improvements at the intersection of State Road 312 and County Road 5-A.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

Section 1. That the County approves the aforementioned Agreement upon the terms and conditions contained therein.

Section 2. That the County Administrator is hereby authorized to execute the agreement on behalf of the Board of County Commissioners of St. Johns County, Florida.

Sectopm 3. That the Clerk is instructed to file the Agreement and mail a copy of the executed Agreement to Brianne L. Sinha, 1519 San Rafael Way, St. Augustine FL 32084.

AGREEMENT

THIS AGREEMENT, made and entered into this 14th day of December , 1993, by and between THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter designated as "County", and Brianne L. Sinha, hereinafter designated as "Owner".

WITNESSETH:

WHEREAS, the Owner desires to donate a portion of her non-homesteaded property, more fully described in Exhibit A, attached hereto, incorporated by reference and made a part hereof (the Property), to the County; and

WHEREAS, it is in the public interest for the County to acquire ownership of the Property necessary for a turn lane and improvements at the intersection of State Road 312 and County Road 5-A; and

WHEREAS, the County and the Owner agree the fair market value of the Property to be donated is \$12,500.00.

NOW THEREFORE, in consideration of the covenants and agreements herein contained, it is mutually agreed between the parties as follows:

- 1. The County hereby accepts the Property as a donation from the Owner for necessary improvements.
- 2. Upon execution of this Agreement by the parties, the Owner will execute a warranty deed conveying the Property to the County in fee simple title with no encumbrances and the County Administrator will complete Section B, Part 1 of form #8283 (Non-cash Charitable Contributions) upon presentation by Owner.
- 3. The County will construct a curb cut into the southwest portion of the Property as close to the intersection as possible but not closer than 100 feet from the right-of-way line of SR 312 and CR 5A pursuant to St. Johns County Ordinance 86-4.

- 4. The County will pay for title insurance, and closing costs for transfer and recording of the deed.
 - 5. Property taxes will be prorated at time of closing.
- 6. This agreement may be amended in writing executed with the same formalities as the original.
- 7. This agreement shall be construed and enforced in accordance with the laws of the State of Florida. Jurisdiction and venue for any dispute hereunder shall be in the Circuit Court of St. Johns County, Florida.
- 8. The executed original of this agreement shall be filed with the Clerk of the St. Johns County Board of County Commissioners, and each party shall receive a certified copy of the recorded agreement.
- 9. This agreement shall be effective upon approval of a resolution by the Board of County Commissioners authorizing the execution of the Agreement by the County Administrator, and execution by all parties hereto.
- 10. This agreement shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto.

If any section, phrase, sentence or portion of this agreement is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.
