A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE RENAMING OF MICKLER'S CUT-OFF IN PALM VALLEY TO THE ORIGINAL NAME OF MICKLER ROAD IN RECOGNITION OF YULEE RAYMOND MICKLER AND HIS DESCENDANTS.

WHEREAS, Yulee Raymond Mickler built his homestead in St. Johns County about the year 1875; and

WHEREAS, Yulee Raymond Mickler and his family were some of the original settlers in the Northeast region of St. Johns County; and

WHEREAS, the road to his homestead was named Mickler Road; and

WHEREAS, Mickler Road was renamed Mickler's Cut-off at some undetermined point in St. Johns County history; and

WHEREAS, the Mickler residents now living on Mickler's Cut-off are direct descendents of Yulee Raymond Mickler; and

WHEREAS, no known reason can be determined from County addressing records necessitating the name change; and

WHEREAS, it is the desire of the descendants of Yulee Mickler that the name of Mickler Road be restored; and

WHEREAS, the restoration of the original name of the roadway now known as Mickler's Cut-off would enhance and perpetuate the sense of community in the Palm Valley area by reminding residents of the community's roots.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that the roadway now named Mickler's Cut-off be restored to its original name of Mickler Road, to maintain its historic origin and to preserve the community spirit of the Palm Valley community.

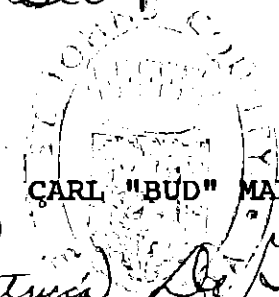
