FROM: Inspection Station Road
TO: Kenton Morrison Road

WHEREAS, an application has been duly made to the Board of County
Commissioners to rename a street;
Inspection Station Road to Kenton Morrison Road.

WHEREAS, the procedure outlined in resolution #92-65 has been
followed by the petitioners;

WHEREAS, the E 9-1-1 Coordinator has reviewed the petition, and
recommends that it be granted; and

WHEREAS, it is found to be in the public interest to rename this
street as requested on furtherance of the public health, safety
and welfare;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The petition to rename a street is hereby granted and
shall hereafter be known by that name.

2. The E 9-1-1 Coordinator is instructed to take whatever
steps are necessary to change the street name and to notify the
Property Appraiser's office of the change.

3. The petitioner shall notify, in writing, all residents
affected by this resolution of the renaming of
Inspection Station Road to Kenton Morrison Road.



Dear Commissioner Roberts:

I represent the three children of F. Kenton Morrison. Two of the children, Irvine Morrison and Marion Triay are residents of St. Johns County and the third child, Andy Morrison, resides in Georgia, but is a frequent visitor to St. Augustine and owns real property here.

Inspection Station Road (which as you may well know runs south from SR 16 and lies immediately west of the old vehicle inspection station) was previously named Morrison Road, but was later renamed Inspection Station Road.

My clients would like to have the road renamed "Ken Morrison Road" in honor of their father. The family continues to own real property abutting the road. This seems particularly appropriate in that the inspection station has been closed for many years.


My clients have spoken to Commissioner Fred Brinkhoff about this matter and therefore I have enclosed a copy of this letter to him as well as to County Administrator Nicholas Meiszer.

Please advise of the appropriate procedure to bring this matter before the County Commission.

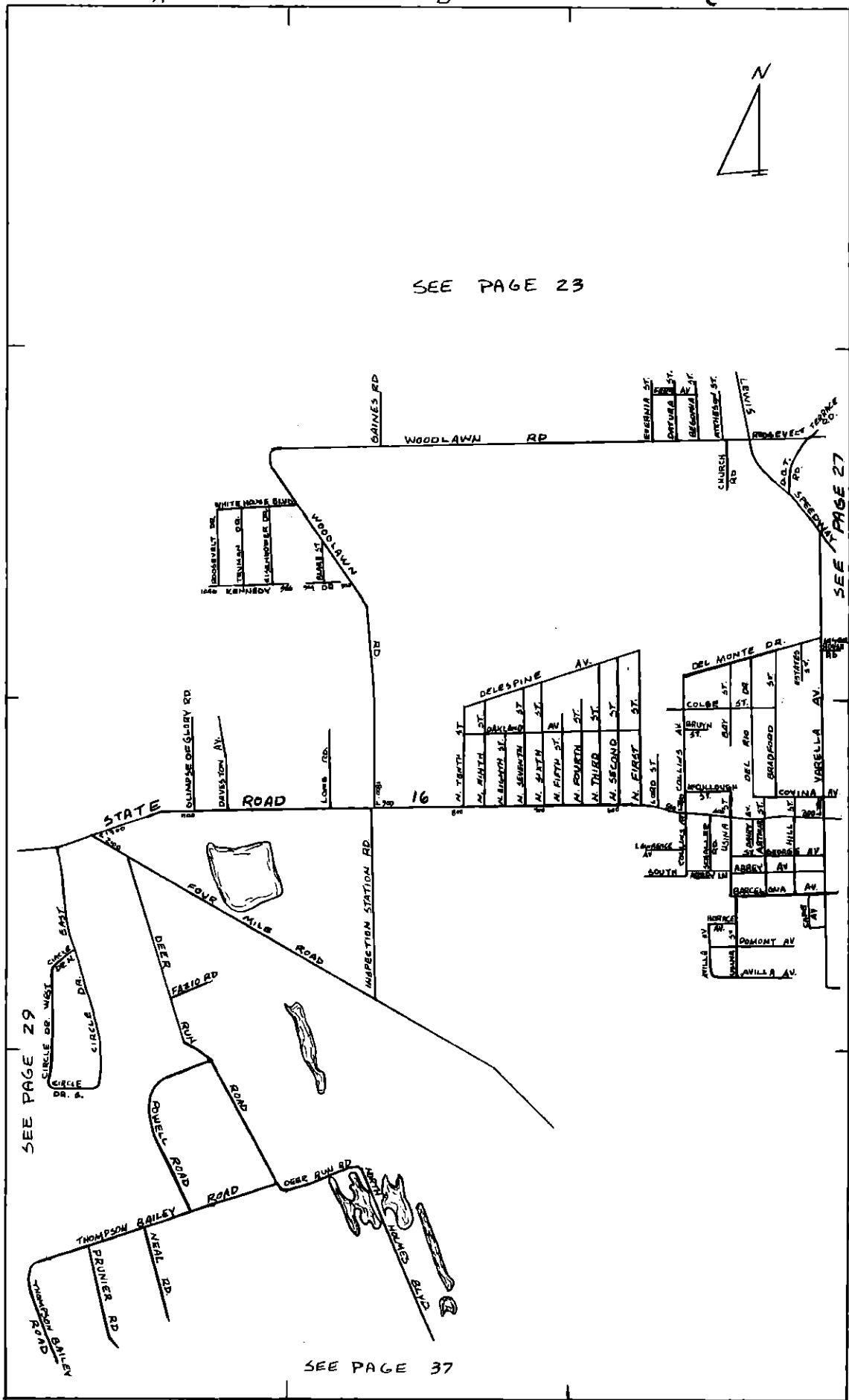
