A RESOLUTION OF THE ST JOHNS COUNTY,  
FLORIDA, BOARD OF COUNTY COMMISSIONERS,  
RENAMING A PORTION OF A STREET

FROM: Mallard Landing Boulevard (between Duck Blind Drive and  
Mallard Lake Ave)

TO: Mallard Landing Boulevard North.

WHEREAS, an application has been duly made to the Board of County  
Commissioners to rename a portion of a street;  
Mallard Landing Boulevard (between Duck Blind Drive and Mallard  
Lake Ave) to Mallard Landing Boulevard North.

WHEREAS, the procedure outlined in resolution #92-65 has been  
followed by the petitioners;

WHEREAS, the E 9-1-1 Coordinator has reviewed the petition, and  
recommends that it be granted; and

WHEREAS, it is found to be in the public interest to rename this  
street as requested on furtherance of the public health, safety  
and welfare;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The petition to rename a portion of Mallard Landing  
Boulevard (between Duck Blind Drive and Mallard Lake Ave) to  
Mallard Landing Boulevard North is hereby granted and shall  
hereafter be known by that name.

2. The E 9-1-1 Coordinator is instructed to take whatever  
steps are necessary to change the street name and to notify the  
Property Appraiser's office of the change.

3. The petitioner shall notify, in writing, all residents  
affected by this resolution of the renaming of a portion of  
Mallard Landing Boulevard (between Duck Blind Drive and Mallard  
Lake Ave) to Mallard Landing Boulevard North.

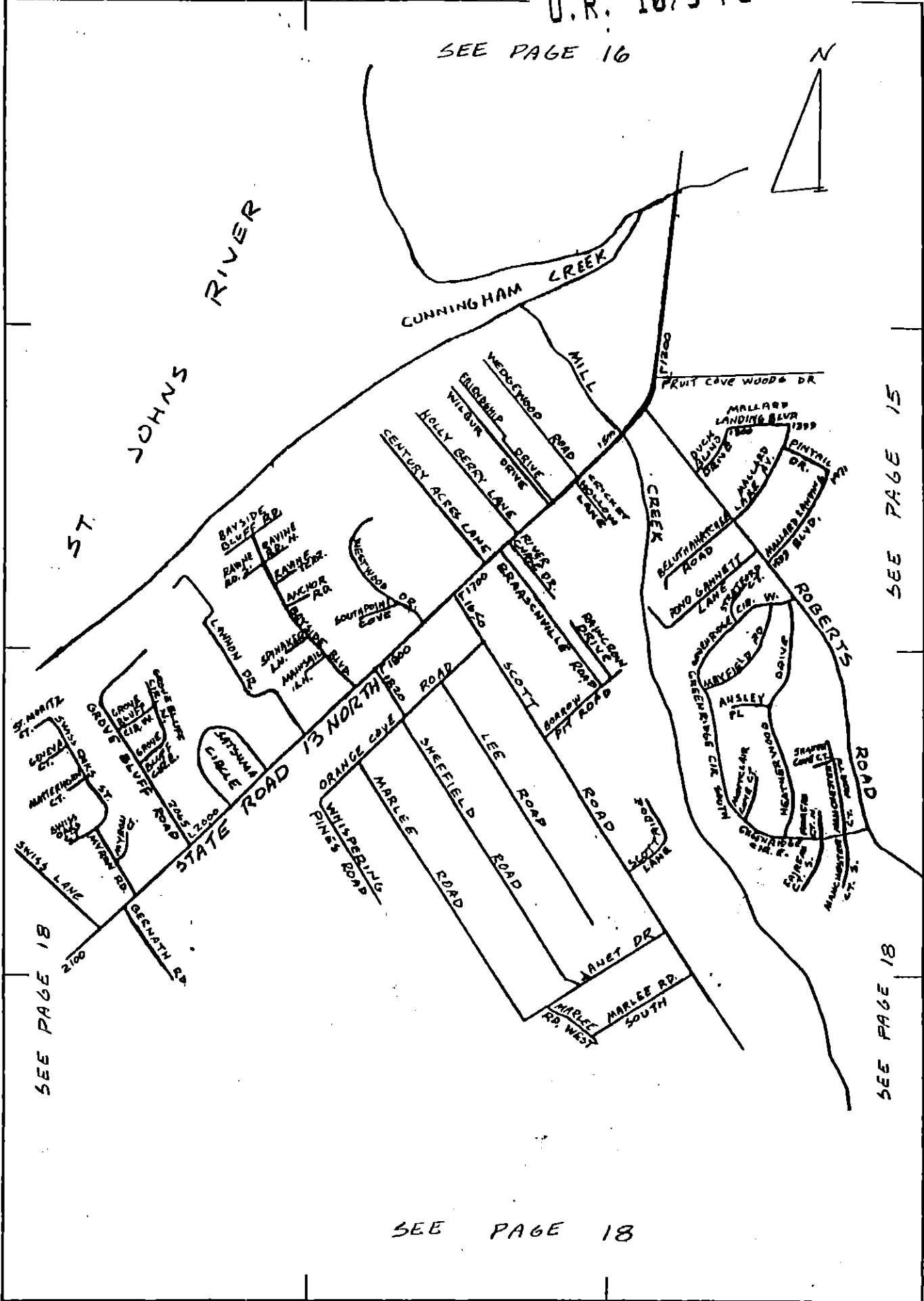

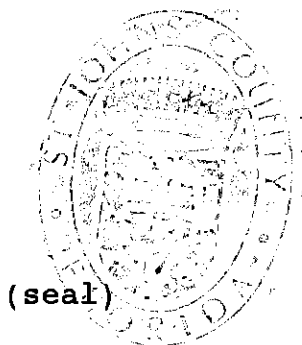
