RESOLUTION NO 94-202

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA APPROVING THE TRANSFER OF OWNERSHIP FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION TO ST. JOHNS COUNTY OF SPECIFIED RIGHT OF WAY FOR USE AS A PUBLIC RECREATIONAL FACILITY PARKING LOT.

WHEREAS, the citizens and visitors of St. Johns County commonly use the State Road AlA bridge over the Matanzas Inlet as a recreational fishing site; and

WHEREAS, the Florida Department of Transportation has recently constructed a public parking lot to provide for vehicle parking to facilitate recreational fishing as a common use of the bridge; and

WHEREAS, maintenance and operation of this public recreational parking lot can more appropriately and effectively be accomplished by St. Johns County as a part of an ongoing public recreation program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

- I. The transfer of ownership of the recreational parking area, as more fully shown and described on the map attached hereto as Exhibit A, incorporated by reference and made a part hereof, is hereby approved and accepted.
- The maintenance and operation of this facility will be included as part of St. Johns County's ongoing recreation program.
- 3. The County Administrator is authorized to accept the Quit Claim Deed from the Department of Transportation and the Clerk is authorized to record the Deed in the Official Records of St. Johns County, Florida.


