per the addendum hereto attached.

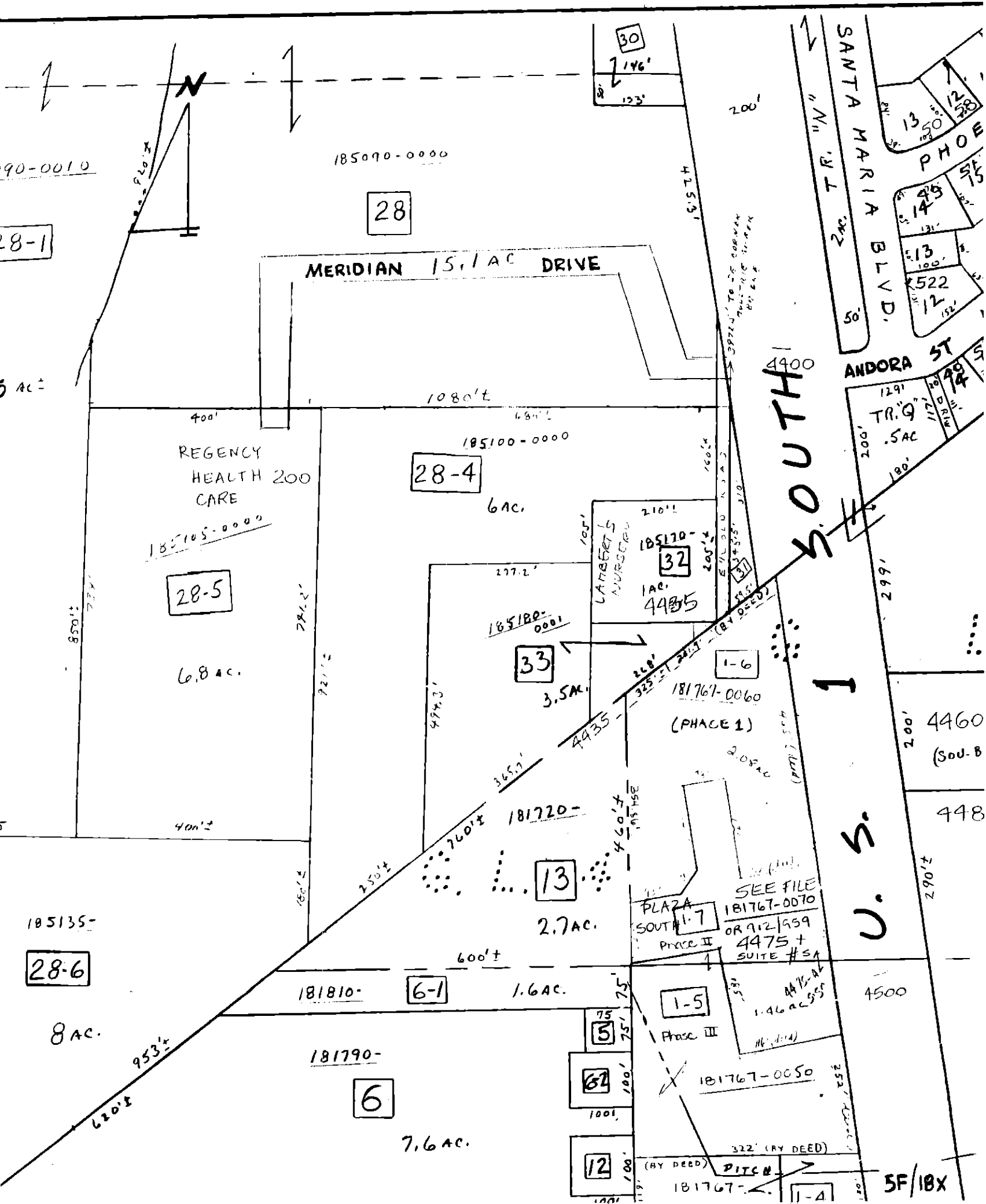
