WHEREAS, it is found to be in the public interest to name this street as requested in furtherance of the public health, safety and welfare;

2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to change the street name and to notify the Property Appraiser's office of the change.
3. The petitioner shall notify, in writing, all residents affected by this resolution of the naming of Gunby Circle.

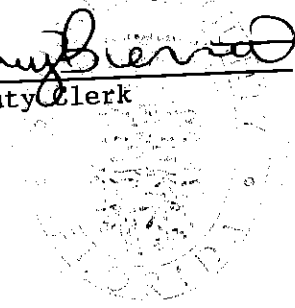

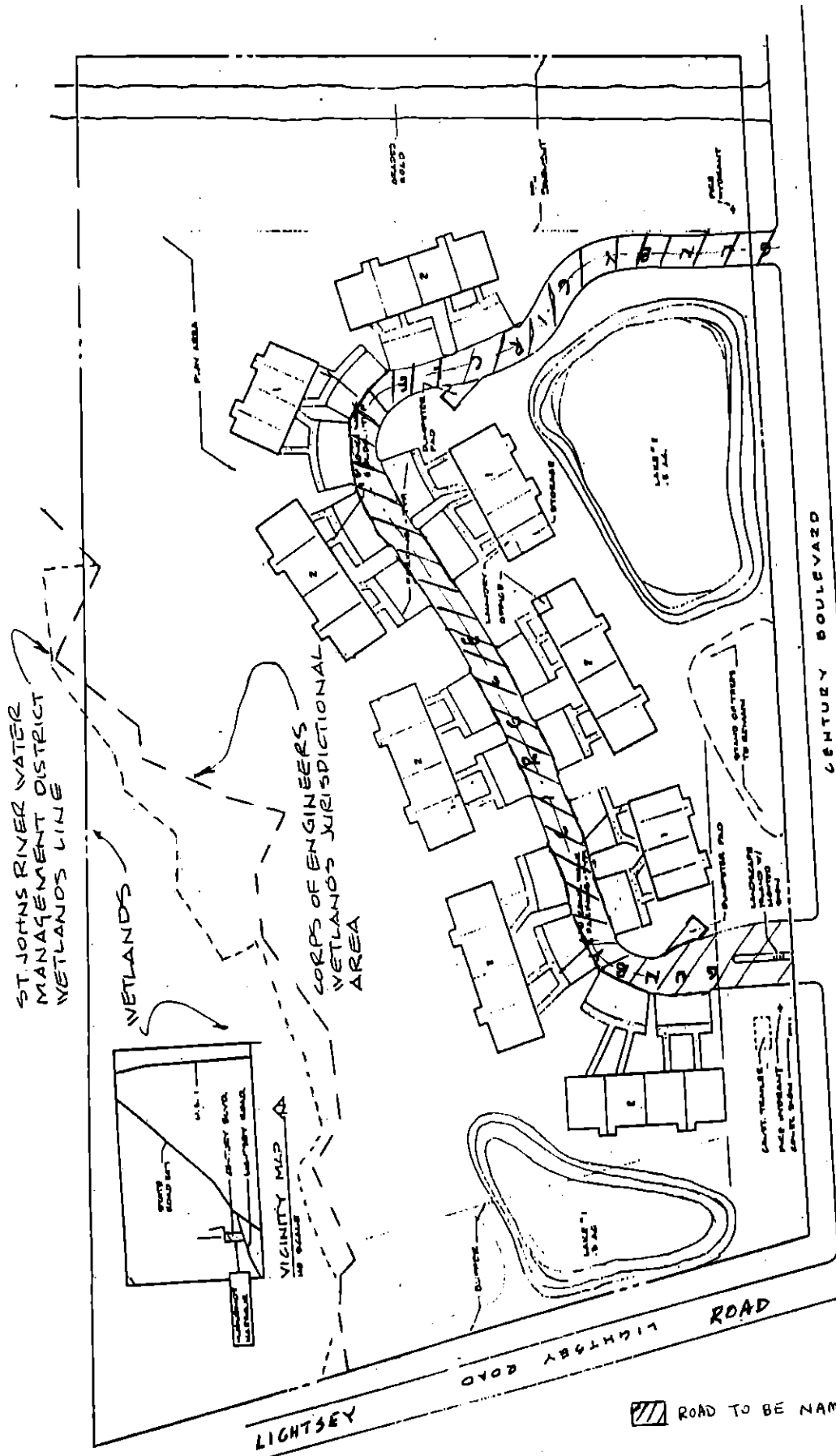

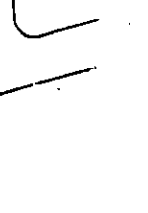
