3. The petitioner shall notify, in writing, all residents affected by this resolution of the naming of Ponte Vedra Colony Circle.

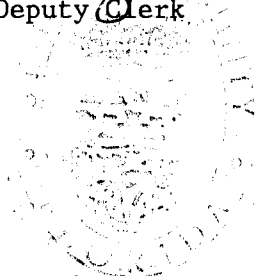

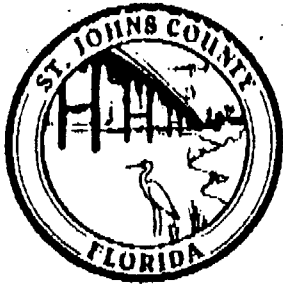

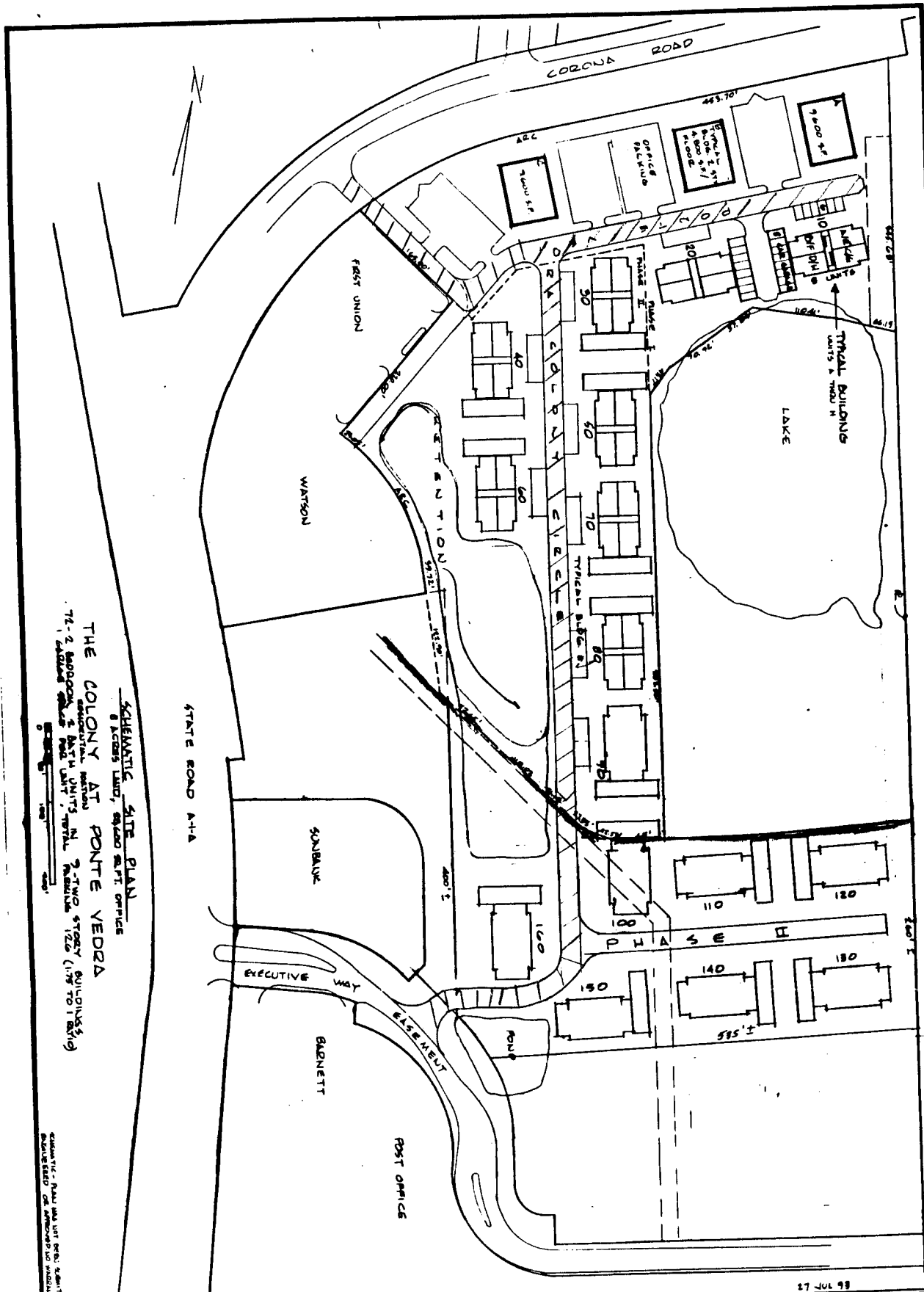
