

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS  
OF ST. JOHNS COUNTY, STATE OF FLORIDA  
APPROVING A CORRECTION TO A STREET NAME ON THE  
PLAT OF SUMMERCHASE, PREVIOUSLY APPROVED ON MAY 24, 1994  
BUT NOT RECORDED AS OF JUNE 1, 1994

WHEREAS, Summerchase Joint Venture has requested by letter attached hereto as Exhibit A that the street name of "Putters Green Way East" on the plat of Summerchase at Julington Creek Unit One approved by the Board of County Commissioners on May 24, 1994, be corrected to read "Putters Green Way South", and

WHEREAS, said plat has not been recorded as of June 1, 1994;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The street name of "Putters Green Way East" on the plat of Summerchase at Julington Creek Unit One subdivision approved by the Board of County Commissioners of St. Johns County on May 24, 1994, shall be changed to read "Putters Green Way South" and that said plat shall be recorded by the Clerk of the County with said change.

Section 2. All preexisting County official signatures on said plat hereby ratified as of this date.
