

### DESCRIPTION

A portion of Julington Creek Unit Five, as shown on plat thereof recorded in Map Book 17, Pages 1 - 21, of the Public Records of St. Johns County, Florida, being more particularly described as follows:

For a Point of Beginning, commence at the most Northerly point of the 25 foot fillet radius curve at the most Southeasterly corner of the aforementioned Julington Creek Unit Five, said curve defining the right-of-way intersection of Durbin Creek Boulevard and Flora Branch Boulevard, as shown on said plat, and said Point of Beginning being the most Easterly corner in the boundary of said Julington Creek Unit Five; thence Southwesterly, along the boundary of said Julington Creek Unit Five and around the arc of said 25 foot radius curve, through a central angle of 80° 37' 57", for an arc distance of 35.18 feet, said arc being subtended by a chord which bears South 25° 10' 08" West, 32.35 feet; thence South 63° 02' 19" West, along the Southerly boundary of said Julington Creek Unit Five, a distance of 204.86 feet; thence North 17° 32' 17" West, departing said Southerly boundary, a distance of 231.40 feet; thence North 65° 29' 16" East, a distance of 225.85 feet to a point lying in the Easterly boundary of said Julington Creek Unit Five; thence South 17° 29' 46" East, along said Easterly boundary, a distance of 201.51 feet to the Point of Beginning.
