Whereas, the Board of County Commissioners on September 12, 1995, adopted the fee schedule for Fiscal year 1996 by adopting Resolution 95-157; and

Whereas, Resolution 95-157 consolidated numerous County Fees previously approved by the County Commission into a central document; and

Whereas, during the preparation of Resolution 95-157, Engineering Fees for Pole/Structure Inspection in the amount of \$20.00 was omitted; and

Whereas, this fee defrays in part for the cost of St. Johns County to inspect work performed on Public Right-of-Ways.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, that Resolution 95-157 be amended to include the Engineering Fee for Pole/Structure Inspection of \$20.00 as previously established in Resolution 94-231
