RESOLUTION NO. 95-180

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY SUSPENDING THE FOUR AND ONE-HALF PERCENT (4 1/2%) REGULATORY FEE COLLECTED FROM WATER AND SEWER UTILITIES IN THE UNINCORPORATED AREAS OF ST. JOHNS COUNTY, FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, every utility regulated by the Board of County Commissioners of St. Johns County pursuant to Ordinance No. 89-63, and amendments thereto, known as the St. Johns County Water and Sewer Utilities Regulatory Ordinance, is required to pay a regulatory fee in the amount of four and one-half (4 1/2%) percent of the utility's gross revenue derived from the utility's operations within the County, and a minimum regulatory fee of Twenty-five and 00/ths Dollars (\$25.00) per annum; and

WHEREAS, the regulatory fees collected to date are anticipated to be sufficient to pay for the ongoing costs of supervising and regulating utilities in the County.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA that:

Section 1. The regulatory fee of four and one-half (4 1/2%) percent of each utility's gross revenue derived from operations within St. Johns County is suspended for the time period of October 1, 1995 through September 30, 1996. For said time period the four and one-half percent (4 1/2%) regulatory fee shall not be collected from utility customers or paid by any utility to St. Johns County. Each utility shall pay the minimum regulatory fee of Twenty-five and 00/ths Dollars (\$25.00) per annum to St. Johns County.

Section 2. All regulatory fees accruing prior to October

1, 1995, shall be collected by each utility and paid to St. Johns County as provided by St. Johns County Ordinance 90-19, and Rule 3.4 of the Supplemental Rules to the St. Johns County Water and Sewer Utilities Regulatory Ordinance.

Section 3. All regulatory fees accruing after September 30, 1996, shall be collected by each utility and paid to St. Johns County as provided by St. Johns County Ordinance No. 90-19, and Rule 3.4 of the Supplemental Rules of the St. Johns County Water and Sewer Utilities Regulatory Ordinance.

Section 4. This Resolution shall take effect on October 1, 1995.
