A RESOLUTION OF THE ST JOHNS COUNTY,

NAMING A STREET
TO: RICHARD'S PLACE.

WHEREAS, an application has been duly made to the Board of County Commissioners to name RICHARD'S PLACE.

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners;

WHEREAS, the E 9-1-1 Coordinator has reviewed the petition, and recommends that it be granted; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The petition to name RICHARD'S PLACE is hereby granted and shall hereafter be known by that name.

2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to name the unnamed street and to notify the Property Appraiser's office of the change.

3. The petitioner shall notify, in writing, all residents affected by this resolution of the name RICHARD'S PLACE.

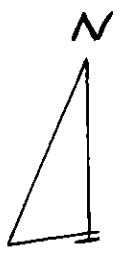
