A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, STATE OF FLORIDA, APPROVING AN EXCHANGE OF REAL PROPERTY EASEMENTS PURSUANT TO SECTION 125.37, FLORIDA STATUTES.

WHEREAS, Darryl B. Hill and Iris E. Hill have requested that the Board of County Commissioners of St. Johns County, Florida partially release its drainage easement on land described in Exhibit A attached hereto and incorporated herein by reference (hereinafter "Exhibit A Easement) which borders certain real property Dr. Hill holds title to; and

WHEREAS, St. Johns County presently has need of said Exhibit A Easement to convey public road stormwater runoff to legal positive outfall, but would not have such need if St. Johns County had title to a similar drainage easement on lands described in Exhibit B attached hereto and incorporated herein by reference (hereinafter Exhibit B Easement) and the County acquired a maintenance access easement on lands described in Exhibit C attached hereto and incorporated herein by reference; and

WHEREAS, an exchange of said Real Property Easements would be in the public interest in that it would allow necessary drainage of stormwater from public roads and would provide the County with a drainage maintenance easement which the County has no adequate substitute at this time; and

WHEREAS, said proposed exchange of real property easements has been advertised in accordance with the requirements of Section 125.37, Florida Statutes

Now Therefore, Be It Resolved by the St. Johns County Board of County Commissioners that:

The County Administrator is hereby authorized to execute a Release of St. Johns County easement rights in that property as described in Exhibit A hereto, but said release shall be executed only after St. Johns County receives and has had recorded an easement adequate to provide for public water drainage across that land described in Exhibit B hereto and only after St. Johns County has received and recorded an easement on that land described in Exhibit C hereto that is adquate to allow St. Johns County drainage maintenance access across and on such land.
