RESOLVED by the Board of County Commissioners of St. Johns County, Florida, this 23 day of January, 1996.

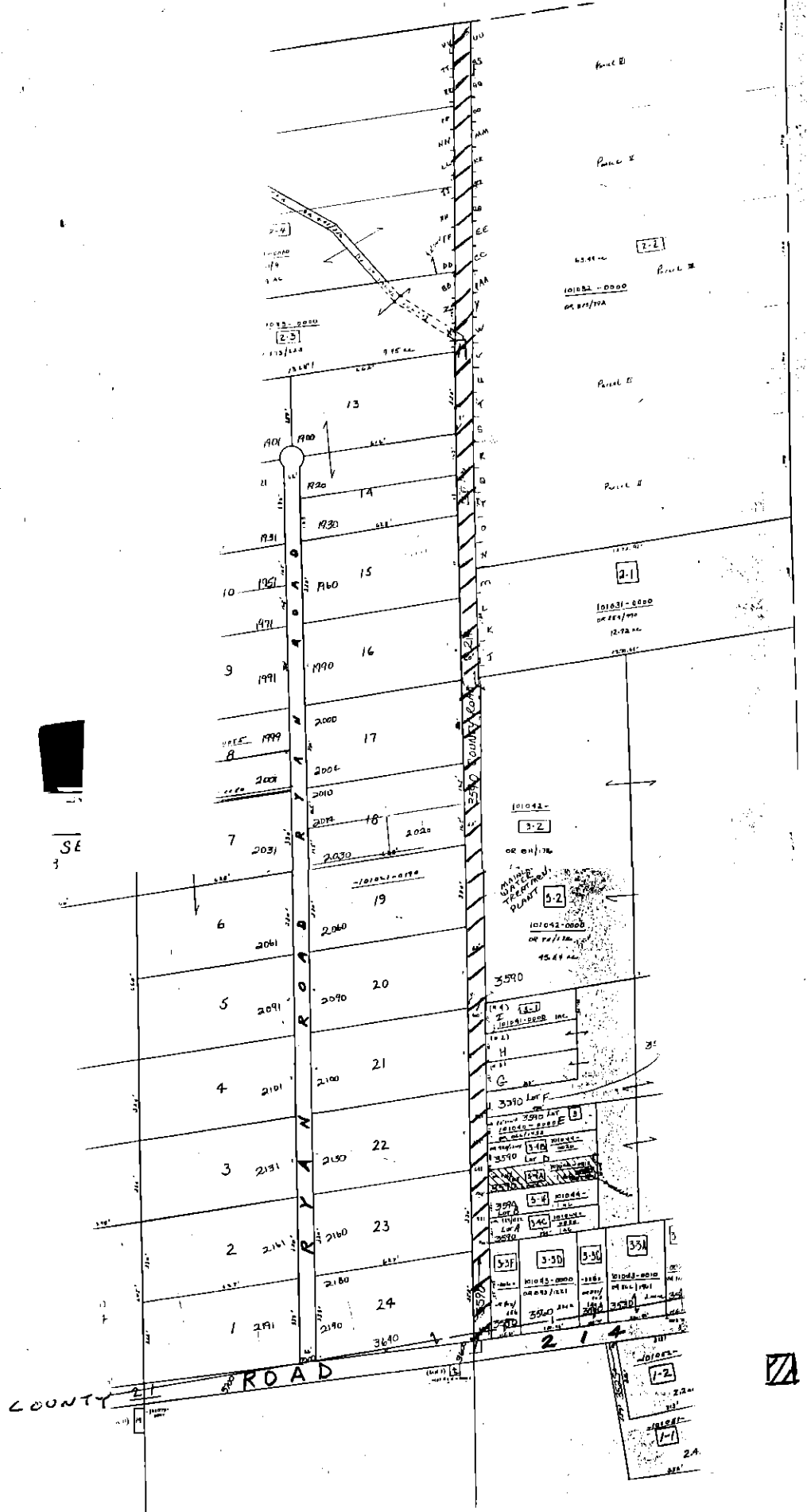

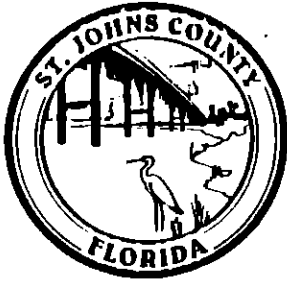
