

RESOLUTION NO. 96 -159

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE EXECUTION OF A TRANSFER AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION AND ST. JOHNS COUNTY FOR VILANO ROAD AND OLD VILANO BRIDGE, ALSO DESCRIBED AS SECTION 78030 OF STATE ROAD A1A FROM MILEPOST 1.483 TO MILEPOST 1.928 WHICH IS FURTHER DESCRIBED AS THE NORTH RIGHT OF WAY LINE OF POPLAR STREET.

WHEREAS, the Florida Department of Transportation has agreed to transfer Vilano Road and Old Vilano Bridge to St. Johns County, according to terms in the Agreement, a copy of which is attached, incorporated by reference and made a part hereof; and

WHEREAS, the Department has requested the transfer of Vilano Road and the County has requested transfer of Old Vilano Bridge from the State Highway System to the County Road System; and

WHEREAS, the County accepts all responsibility for operation and maintenance of the roadway described above including all curbs, culverts, drainage structures and sidewalks within the right of way at the time of transfer; and

WHEREAS, The County agrees to maintain Vilano Road and Old Vilano Bridge in accordance with federal guidelines; and

WHEREAS, right of way maps will be recorded by the County; and

WHEREAS, the County agrees to accept \$110,000 from the Department to perform the work necessary to bring the roadway into compliance with current Department standards.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida as follows:

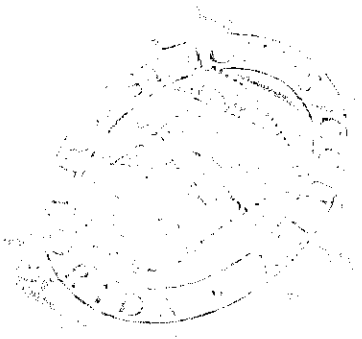
Section 1. The County Administrator is hereby authorized to execute the above described Transfer Agreement in substantially the form attached hereto.

Section 2. This transfer agreement will set forth the terms and conditions under which the County and FDOT will abide, commencing on the date of approval by the FDOT's Secretary.

Section 3. A copy of the Resolution shall be forwarded to FDOT in order to advise them of the County's intent to execute such a Transfer Agreement with a representative of the Department.

Section 4. The Clerk is authorized to record the Transfer Agreement and file the Agreement in the public records of St. Johns County, Florida.
