A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY RELATING TO THE WAIVER OF UNIT CONNECTION FEES IN ACCORDANCE WITH THE "WINDOW OF OPPORTUNITY"; AND PROVIDING A DEADLINE EXTENSION FOR CUSTOMERS TO HOOK UP DUE TO UNAVOIDABLE DELAYS ENCOUNTERED BY THE ST. JOHNS COUNTY UTILITY DEPARTMENT.

WHEREAS, St. Johns County Ordinance 96-13 provides that the Board of County Commissioners of St. Johns County may waive all or any water unit connection fees, and/or all or any sewer unit connection fees, temporarily or permanently, in whole or in part by resolution of the Board; and

WHEREAS, St. Johns County Resolution 96-31 provides for waiver of unit connection fees, under certain conditions, for customers who previously utilized non-County utility facilities; and

WHEREAS, St. Johns County Resolution 96-31 specifies that if a utility account is created and committed to by April 30, 1996, a one hundred percent (100%) waiver of unit connection fees will be granted if actual connection occurs within six (6) months of the creation of the account; and

WHEREAS, the customers listed in Exhibit A, attached hereto and incorporated herein by reference, all created wastewater accounts and committed to wastewater services with the defined "Window of Opportunity" and qualified for one hundred percent (100%) waiver of sewer unit connection fees; and

WHEREAS, due to unforeseen circumstances and unavoidable delays, wastewater service provision to these customers will not be available within the specified six (6) month period.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA as follows:

The customers listed in Exhibit A, plus any other customers in the process of connecting under the Window of Opportunity program, but who have not completed connection, will receive one hundred percent (100%) waiver of sewer unit connections fees system, provided that actual connection occurs within thirty (30) days of notification by the County that service is available.
