

RESOLUTION NO. 96-199

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA, CLOSING PORTIONS OF COUNTY ROAD 203 (PONTE VEDRA BOULEVARD) AND MICKLER ROAD TO VEHICULAR THROUGH TRAFFIC.

WHEREAS, it is in the interest of public safety to provide adequate off-street parking facilities for the people of St. Johns County to access Mickler Beach; and

WHEREAS, there is a need for the use of portions of St. Johns County right-of-way, as it will serve to enhance and expand the capacity of the proposed Mickler Beach Access Parking Lot; and

WHEREAS, traffic on County Road 203 (Ponte Vedra Boulevard) will not be adversely impacted as there are reasonably convenient alternate routes.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida that:

Section 1. That a portions of County Road 203 and Mickler Road are hereby closed to vehicular through traffic and in lot access between the below described lines and in accordance with the site plan attached hereto and incorporated herein by reference as Exhibit A.

SOUTH LINE: For a point of reference, commence at the Southwesterly corner of Lot 2 "S" Ocean Front Dunes as recorded in Map 13, Pages 69 and 70 of the Public Records of St. Johns County, Florida, said point lying on the Wasterly right of way line of County Road No. 203 (State Road No. 203 - formerly S. R. No. 78 and /or Highway A1A by plat); thence North 13° 05' 00" west, along said Easterly right of way line, a distance of 10.00 feet to the point of beginning of the line herein described; thence South 76° 55' 00" West a distance of 66.00 feet to a point on the Westerly right of way line of aforementioned County Road No. 203 and the point of terminus of said line.

NORTH LINE: 712 feet North of, parallel with and perpendicular to the above described South Line.

WEST LINE: 385 feet West of, parallel with and perpendicular to the Easterly right of way line of County Road No. 203 (State Road No. 203 - formerly S. R. No. 78 and /or Highway A1A) as shown of the plat of Ocean Front Dunes as recorded in Map 13, Pages 69 and 70 of the Public Records of St. Johns County, Florida.

Section 2. This road closure does and shall not act as a vacation of any portion

of public or county right of way.
