

RESOLUTION 96-21

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING RESOLUTION 86-169 AS PREVIOUSLY AMENDED BY RESOLUTION 92-65. THIS RESOLUTION CLARIFIES THE INTENT OF SUCH RESOLUTIONS BY SPECIFICALLY PROVIDING THAT THE BOARD OF COUNTY COMMISSIONERS MAY ESTABLISH AND/OR CHANGE THE NAME OF ANY COUNTY CONNECTOR AND/OR COUNTY ARTERIAL ROAD WITHIN ST. JOHNS COUNTY BY THE PASSAGE OF A RESOLUTION INITIATED BY THE BOARD OF COUNTY COMMISSIONERS PROVIDED ONLY THAT SUCH NEWLY ESTABLISHED NAME DOES NOT DUPLICATE THE NAME OF ANOTHER EXISTING ROAD WITHIN THE COUNTY AND THE FOLLOWING 2 FACTORS ARE FIRST CONSIDERED BY THE BOARD: HISTORIC VALUE, IF ANY, OF THE EXISTING NAME OF THE ROAD; AND PETITIONS, IF ANY, OF PERSONS AND ENTITIES RESIDING AND/OR OWNING PROPERTY WITHIN THE GENERAL AREA OF SUCH ROAD.

BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida that St. Johns County Resolutions 86-169 and 92-65 are hereby amended by adding the following paragraph 6 thereto:

6. Notwithstanding any other provision of Resolutions 86-169 and 92-65, the Board of County Commissioners may establish and/or change the name of any County connector and/or County arterial road within St. Johns County by the passage of a resolution upon the request or motion of a member of the Board of County Commissioners without regard to the other procedures set forth in resolutions 86-169 and 92-65 provided only that:

- A. Such newly established name does not duplicate the name of another existing road within the County ; and
- B. The following 2 factors are first considered by the Board:
  - (1) The historic value, if any, of the existing name of the road; and
  - (2) Petitions pertaining to the naming of the road, if any, signed by persons and entities residing and/or owning property within the general area of such road.

The Board may give such weight as it deems appropriate to each factor.
