A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA REVOKING A LICENSE GRANTED TO WILLIAM K. MOELLER FOR ACCESS TO HIS PRIVATE PROPERTY ADJOINING THE COUNTY PARKING LOT LOCATED ON CORDOVA STREET.
