WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;


NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

3. The petitioner shall notify, in writing, all residents affected by this resolution.

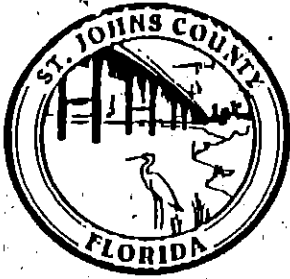
