

RESOLUTION NO. 97-92

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY DELEGATING AUTHORITY OF THE BOARD OF COUNTY COMMISSIONERS TO THE COUNTY ADMINISTRATOR TO EXECUTE A GENERAL AGREEMENT WITH THE PONTE VEDRA VOLUNTEER FIRE DEPARTMENT, INC. FOR THE PURPOSES OF PROVIDING FIRE FIGHTING AND EMERGENCY MEDICAL SERVICES IN A CERTAIN AREA OF ST. JOHNS COUNTY.

WHEREAS, St. Johns County coordinates with and relies on the Ponte Vedra Volunteer Fire Department, Inc. to provide fire fighting and emergency medical services in a certain area of the County, more particularly described in Exhibit "A"; and

WHEREAS, the County is in the process of organizing and formalizing relations with each of the 15 Volunteer Fire Departments operating at various locations in the County; and



WHEREAS, the County Administrator is responsible to administer and carry out resolutions and directives of the Board of County Commissioners:



**EXHIBIT "A"**

**STATION # 10**

From the Duval/St. Johns County line South along the I.C.W. to a point where N. Roscoe Blvd. curves East to Solana Rd. All properties Northeast of this point to Solana Rd. and A1A, including the intersection of A1A and Solana Rd. South on A1A to Corona Rd., including A1A and the intersection of Corona Rd. and A1A. Continue South on A1A to Mickler's Landing, not including A1A. From this point North along the Atlantic Ocean to the Duval/St. Johns County Line.

## GENERAL AGREEMENT

THIS AGREEMENT, made this \_\_\_\_ day of June, 1997; by and between Ponte Vedra Volunteer Fire Department, Inc. ("PVVFD"), and St. Johns County ("County").

WHEREAS, St. Johns County coordinates with and relies on the Ponte Vedra Volunteer Fire Department, Inc. to provide fire fighting and emergency medical services in a certain area of St. Johns County, more particularly described in Exhibit "A"; and

WHEREAS, the County is in the process of organizing and formalizing relations with each of the 15 Volunteer Fire Departments operating at various locations in the County; and

WHEREAS, Ponte Vedra Volunteer Fire Department, Inc. is the primary Fire Station for the area described in Exhibit "A" and the County is not provided with any other firefighting services obligated for service in that area;

WITNESSETH: That in consideration of the mutual covenants and agreements to be kept and performed on the part of said parties hereto, respectively as herein stated, PVVFD and the County do hereby covenant and agree that they shall perform the following activities:

PVVFD shall:

- (a) Provide continual fire fighting and emergency medical services for the area of St. Johns County described in Exhibit "A". PVVFD shall be the primary provider of said services in said area, but shall not have the exclusive right to provide said services.
- (b) Coordinate training and operations with County Fire Chief and Staff.
- (c) Be responsible for management of PVVFD personnel.

County shall:

- (a) Facilitate training, vehicle maintenance, and coordination between PVVFD and other volunteer fire departments within St. Johns County.
- (b) Provide administrative assistance as needed.

This Agreement shall be binding upon the parties, their successors, assigns and personal representatives. Time is of the essence on all undertakings. This agreement shall be enforced under the laws of the State of Florida. This is the entire agreement.

Signed the day and year first above written. This General Agreement shall expire upon the execution of any subsequent contract or written agreement between the parties, or September 1, 1997, which ever occurs first.
