

RESOLUTION NO. 98 - 138

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING THE FISCAL YEAR 1998 GENERAL REVENUE AND EXPENDITURE BUDGETS TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE AS A DONATION TO THE ST. JOHNS COUNTY SHERIFF'S OFFICE CRIME PREVENTION PROGRAM.

WHEREAS, St. Johns County has created a special Law Enforcement Trust Fund under the terms of Florida Statute 932.7055 for the deposit of proceeds resulting from the lawful liquidation of properties seized and forfeited by final judgement under the Florida Contraband Forfeiture Act; and

WHEREAS, F.S. 932.7055 (c) 3. requires that, after July 1, 1992, any law enforcement agency which annually acquires at least \$15,000 under the Act expend or donate at least 15 percent of such proceeds for the support or operation of a program authorized under F.S. 932.7055; and

WHEREAS, revenues amounting to \$52,281 were accrued to this trust fund in accordance with the requirements of F.S. 932.7055 during the 1996/97 Fiscal Year; and

WHEREAS, revenues amounting to \$9,490 have been accrued to date in the FY 1997/98 Law Enforcement Trust Fund; and

WHEREAS, the program to be the recipient of such donation is at the discretion of the local law enforcement agency and the Sheriff of St. Johns County has requested that a donation in the amount of \$7,850 be made to the St. Johns County Sheriff's Office Crime Prevention Program; and

WHEREAS, a donation of these funds to the St. Johns County Sheriff's Office Crime Prevention Program is an approved use under the terms of F.S. 932.7055 (4) (a).

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County that:

1. The above "Whereas" statements are adopted as a finding of fact.
2. The General Fund revenue budget shall be adjusted to account for the unanticipated revenue in the amount of \$9,490.
3. An amount of \$9,490 from this total be used as a donation to the St. Johns County Sheriff's Office Crime Prevention Program.
4. The remaining \$1,640 in the Law Enforcement Trust Fund be used for purposes authorized under F.S. 932.7055.
