RESOLUTION NO. 99-105

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING TRANSFER OF A CERTAIN PORTION OF COUNTY OWNED RIGHT-OF-WAY TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENTS TO STATE ROAD NO. 16.

WHEREAS, the State of Florida Department of Transportation purposes to construct or improve State Road No. 16, Section No. 78060-2505, in St. Johns County, Florida; and

WHEREAS, it is necessary that a certain portion of a County owned right-of-way, as described in County Deed attached hereto as Exhibit "A", incorporated by reference and made a part hereof, that abuts proposed project be acquired by the State of Florida Department of Transportation; and

WHEREAS, said property is not needed for County purposes; and

WHEREAS, the State of Florida Department of Transportation has made an application to St. Johns County to execute and deliver to the State of Florida Department of Transportation a County Deed in favor of the State of Florida Department of Transportation, conveying all rights, title and interest that the County has in and to the said land required for transportation purposes.

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- Section 1. The application of the State of Florida Department of Transportation for a County Deed is for transportation purposes which are in the public or community interest and for public welfare, and the land needed for transportation and other purposes is not needed for County purposes.
- Section 2. A County Deed in favor of the State of Florida Department of Transportation conveying all rights, title and interest of St. Johns County, without warranty of title or warranty of method of conveyance, in and to the land described thereon for transportation and other road purposes shall be executed by the Chairman of the Board of County Commissioners. Consideration shall be \$1.00.
- Section 3. A certified copy of this Resolution shall be forwarded forthwith to the State of Florida Department of Transportation, Post Office Box 1089, Lake City, Florida 32056-1089.
- Section 4. The County Deed transferring the property to the State of Florida Department of Transportation shall be duly recorded in the Official Records of St. Johns County, Florida.
