

RESOLUTION NO. 99-149

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA APPROVING A "MARKET NAME" FOR THE DELEON SHORES AND WELLINGTON-BY-THE-SEA SUBDIVISIONS.

WHEREAS, the request for a "market name" change is consistent with the spirit and intent of the Comprehensive Plan and the Ponte Vedra Zoning District Ordinance; and,

WHEREAS, Board approval of the proposed "market name" is solely for the purpose of obtaining a subdivision sign for both subdivisions along State Road A1A North in compliance with Section X.E.5 of the Ponte Vedra Zoning District Regulations; and

WHEREAS, a majority of lot owners in both the DeLeon Shores and Wellington-by-the-Sea subdivisions have indicated by petition that they desire a name change:

Now therefore BE IT RESOLVED by the Board of County Commissioners of St. Johns County that:

1. The above "whereas" statements are adopted as findings of fact.
2. The name "Dolphin Cove" is accepted as the "market name" for the DeLeon Shores and Wellington-by-the-Sea subdivisions for the purposes stated above.
