RESOLUTION NO. 99-171

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA, VACATING A PORTION OF RIVIERA BOULEVARD WHICH CROSSES THROUGH PORTIONS OF LOTS 45, 46, 47, 48, 49 AND 50 IN BLOCK 185, ST. AUGUSTINE SHORES SUBDIVISION UNIT EIGHT AS MORE FULLY DESCRIBED BELOW.

WHEREAS, as petition has been filed by qualified land owners to vacate part of certain public streets, alleyways, or roads hereinafter described; and,

WHEREAS, it appears that the averments of said petition are true,

NOW, THERFORE, INCONSIDERATION OF THE PREMISES, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:




