

## RESOLUTION NO. 99 - 49

### A RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AUTHORIZING ITS SUPPORT FOR PARTICIPATION IN THE WATERFRONTS FLORIDA PROGRAM; DIRECTING COUNTY STAFF TO SUBMIT A FUNDING APPLICATION IN SUPPORT OF SAID PROGRAM; DIRECTING THAT WATERFRONTS FLORIDA PROGRAM INITIATIVES AND VISIONING DOCUMENT BE USED IN PROGRAM IMPLEMENTATION

**WHEREAS**, the residents and business owners of County Commission Southern District 4 have worked together and in partnership with St. Johns County Planning Department to develop and cause to be adopted by the St. Johns County Board of County Commissioners a Vision; and

**WHEREAS**, that Vision reflects a future for Southern District 4 that displays many desired aspects and attributes that the residents and business owners wish for their future; and

**WHEREAS**, the Board of County Commissioners support public-private partnership participation in the Waterfronts Florida Program, an initiative of the Florida Department of Community Affairs to revitalize Florida's waterfronts; and

**WHEREAS**, the Board of County Commissioners wishes to support and stimulate spatial and economic revitalization of Southern District 4 barrier islands; and

**WHEREAS**, the Board of County Commissioners wishes to express its support for seeking designation of these barrier islands as one of the Waterfronts Florida Communities to be selected by July 1999; and

**WHEREAS**, North Shores Improvement Association has expressed a strong interest in working in partnership with St. Johns County government, target area business owners and private sector interest to support and stimulate spatial and economic revitalization; and

**WHEREAS**, many of the Objectives and Actions in the Southern District 4 (Vilano Beach) Vision Document and Initiatives in the Waterfronts Florida Program can only be accomplished by St. Johns County; and

**WHEREAS**, the Board of County Commissioners recognize that many of the proposals in the Southern District 4 (Vilano Beach) Vision Document are indeed meritorious;

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida that the Board of County Commissioners supports County participation in the Waterfronts Florida Program; directs County staff to submit a funding application to the Florida Department of Community Affairs; and further directs that North Shores Community Waterfronts Revitalization Initiatives together with adopted Southern District 4 (Vilano Beach) Vision Document be used in part or in whole to implement the Waterfronts Florida Program.
