

RESOLUTION NUMBER 99 - 64

**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING THE SCHEDULE OF FEES FOR THE COUNTY PLANNING DEPARTMENT.**

**WHEREAS**, the Board of County Commissioners of St. Johns County, Florida is empowered to set fees relating to the provision of services provided by certain County departments;

**WHEREAS**, Resolution 99-12 adopted the County Fee Schedule that County departments charge for specific services;

**WHEREAS**, from time to time it is necessary to revise the fee schedule to allow charges for new services provided by the County;

**WHEREAS**, the St. Johns County Planning Department has established services to provide a Architectural Review Committee (ARC) Minor Review and Appeals to ARC decisions; and

**WHEREAS**, the Board of County Commissioners has indicated that the fees charged for services related to growth should cover the total cost, indirect and direct, of providing said services; and

**WHEREAS**, the County Fee Schedule adopted by Resolution 99-12 now requires revision to implement fees necessary to reasonably reimburse the County for the current cost of providing those services.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that;

**Section 1.** Resolution 99-12, which establishes the County Fee Schedule is hereby modified. Such modification shall not reinstate resolutions previously rescinded by Resolution 99-12.

**Section 2.** The schedule of fees and charges for new services, titled **Overlay District Architectural Review Fees**, which are attached hereto, for a Architectural Review Committee Minor Review and for Appeals to ARC decisions and made part hereof as Exhibit "A" are hereby adopted. Exhibit "A" is to be inserted into the pre-existing fee schedule delineated in Resolution 99-12 at the point immediately following "Concurrency Review Application Fees."

**Section 3.** If the Board of County Commissioners finds that it is in the best interest of the County and will serve a public purpose to waive any described fees on the attached Exhibit "A" of this resolution, the Board of County Commissioners may waive the required fees.

**Section 4.** Effective Date

This Resolution shall take effect upon adoption.
