

**RESOLUTION NO. 99- 68**

**RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF  
ST. JOHNS COUNTY, FLORIDA, ACCEPTING ADDITIONAL  
FUNDING AND AMENDING THE LIBRARY BUDGET.**

**WHEREAS**, the Board of County Commissioners of St. Johns County, Florida adopted a Fiscal Year 1998/99 operating budget for the St. Johns County Library which contained grant fund expenditures; and

**WHEREAS**, the amounts budgeted for that purpose in the Fiscal Year 1998/99 were based on estimates made prior to the award of a grant which had been applied for; and

**WHEREAS**, the State of Florida has approved an amount of funds higher than that budgeted by \$49,593; and

**WHEREAS**, the additional funds cannot be spent for their intended purpose without acceptance by the Board of those monies and an increase in the Library's budgeted appropriations in a like amount; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of St. Johns County, Florida, that the St. Johns County Library's budget for Fiscal Year 1998/99 be adjusted to account for this unanticipated revenue and its appropriations amended to account for its expenditure during Fiscal Year 1999.
