RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING ADDITIONAL FUNDING AND AMENDING THE LIBRARY BUDGET.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida adopted a Fiscal Year 1998/99 operating budget for the St. Johns County Library which contained grant fund expenditures; and

WHEREAS, the amounts budgeted for that purpose in the Fiscal Year 1998/99 were based on estimates made prior to the award of a grant which had been applied for; and

WHEREAS, the State of Florida has approved an amount of funds higher than that budgeted by \$49,593; and

WHEREAS, the additional funds cannot be spent for their intended purpose without acceptance by the Board of those monies and an increase in the Library's budgeted appropriations in a like amount; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that the St. Johns County Library's budget for Fiscal Year 1998/99 be adjusted to account for this unanticipated revenue and its appropriations amended to account for its expenditure during Fiscal Year 1999.
