RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUE FOR THE MARSHALL CREEK COMMUNITY DEVELOPMENT DISTRICT APPLICATION AND ESTABLISHING AN OPERATING BUDGET FOR USE OF ITS FUNDS.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida adopted a Fiscal Year 1998/99 operating budget for the County which contained budgets for both revenue and expenditures; and

WHEREAS, the amounts budgeted for those purposes in the Fiscal Year 1998/99 were based on estimates made prior to the beginning of the Fiscal Year; and

WHEREAS, an application was made for a Community Development District (CDD) after the start of the Fiscal Year and an application fee in the amount of \$15,000 paid; and

WHEREAS, CDD application fees must be spent for the purpose of review and assessment of the CDD which has been applied for; and

WHEREAS, the funds from the application fees cannot be spent for their intended purpose without acceptance by the Board of those monies and an increase in budgeted appropriations in a like amount; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that the St. Johns County General Fund budget for Fiscal Year 1998/99 be adjusted to account for this unanticipated revenue and appropriations amended to account for its expenditure during Fiscal Year 1999.
