**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA  
RENAMING SHADY LANE TO RIVER MARSH LANE.**

**WHEREAS**, an application has been duly made to the Board of County Commissioners to rename Shady Lane to River Marsh Drive; and

**WHEREAS**, the procedure outlined in Resolution #92-65 has been followed by the petitioners; and

**WHEREAS**, it is found to be in the public interest to rename this street as requested on furtherance of the public health, safety, and welfare.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners as follows:

Section 1. The petition to rename Shady Lane to River Marsh Drive and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to rename the street and to notify the Property Appraiser's Office of this change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.

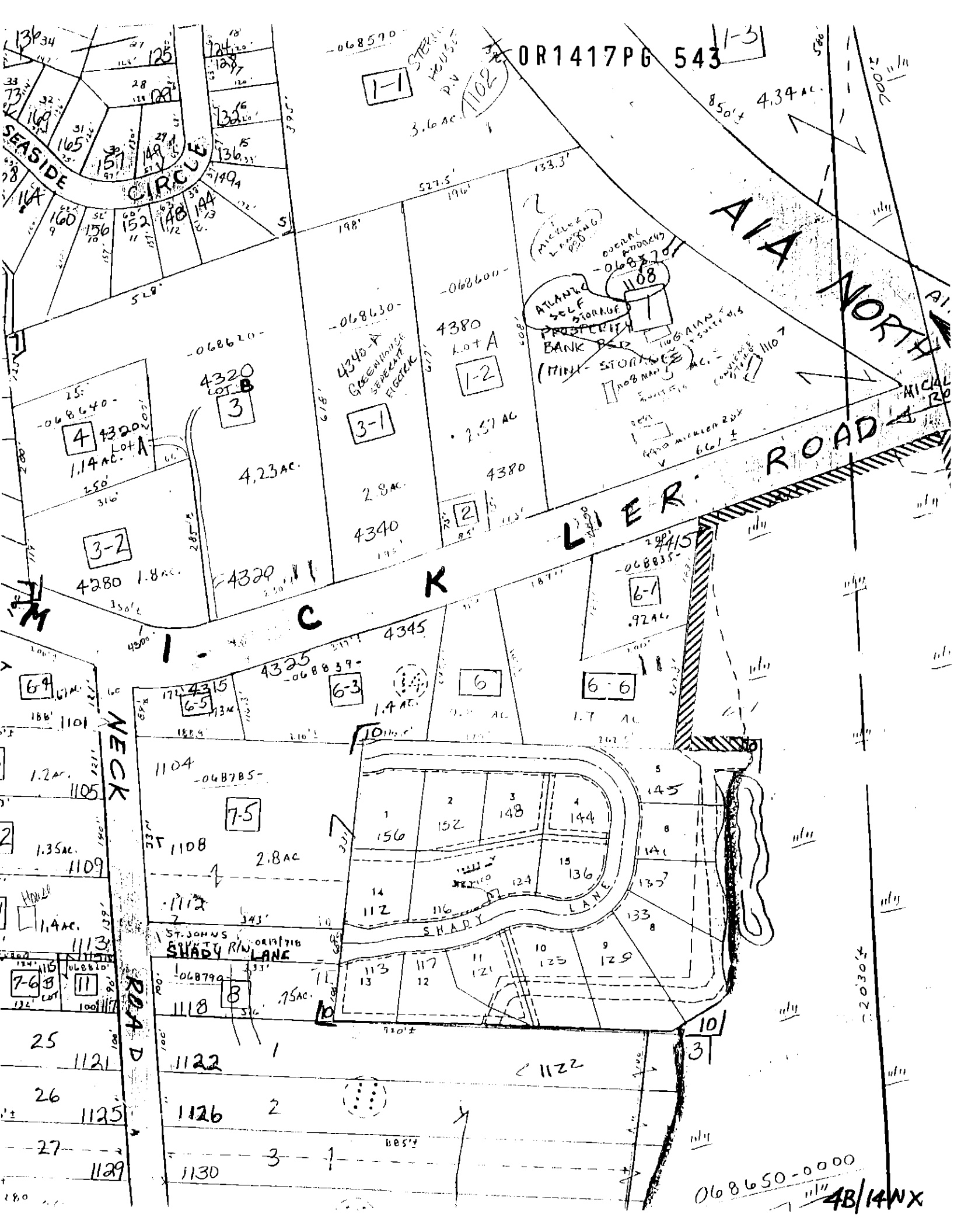

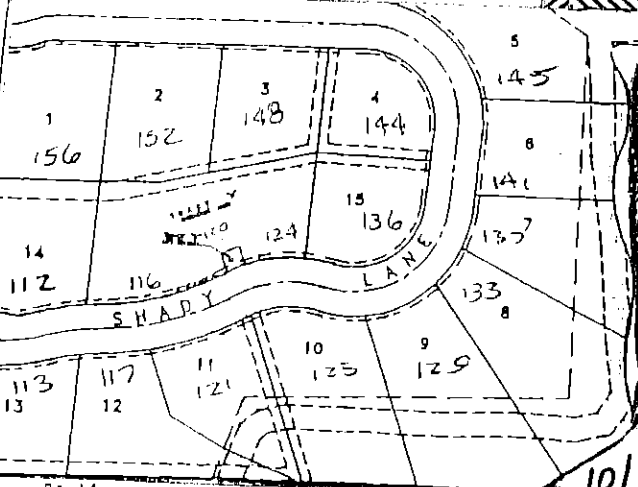


