TEMPORARY CONSTRUCTION EASEMENT

THIS EASEMENT made this Aday of March, 2000, by and between THE SCHOOL BOARD OF ST. JOHNS COUNTY, FLORIDA, a political subdivision of the State of Florida, whose address is 4020 Lewis Speedway, St. Augustine, Florida 32084, Grantee.

WITNESSETH that for and in consideration of the sum of One Dollar (\$1.00) and other Valuable considerations, receipt and sufficiency of which is hereby acknowledged, the grantor hereby gives, grants, bargains and releases to the grantee, a temporary easement for the purpose of building a sidewalk, thereon with the construction to be undertaken by the County, in Greenbriar Road adjacent thereto, in, upon, over and through the following described land in St. Johns County, Florida described as follows:

Part of the Francis Philip Fatio Grant of Section 44, Township 5 South, Range 26 East, St. Johns County, Florida, and being more particularly described as follows:

The Southerly 27 feet (22 feet + 5 feet) of the parcel of land described in deed recorded in Official Records Book 869, page 1615, of the public records of St. Johns County, Florida.

THIS EASEMENT is granted upon the condition that any work performed upon the above described land shall conform to all existing structural improvements within the limits designated, and all work be performed in such a manner that the existing structural improvements will not be damaged.

It is understood and agreed by the parties hereto that the rights granted herein shall terminate upon completion of this transportation project.
