

RESOLUTION 2000 - 69

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY FLORIDA, AMENDING THE FISCAL YEAR 2000 BUDGET TO RECEIVE UNANTICIPATED GRANTS REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY SOLID WASTE DEPARTMENT.**

**WHEREAS**, the County operating budget is annually prepared prior to knowing the actual amount of grant funds which may be awarded by "Keep Florida Beautiful, Inc." (KFB); and

**WHEREAS**, the County has historically received funds from the KFB to provide services; and

**WHEREAS**, St. Johns County, Florida, when preparing the budget for Fiscal Year 2000, did not anticipate receiving additional funds from KFB above and beyond those projected by its Solid Waste Department; and

**WHEREAS**, KFB has approved additional funds that exceed those budgeted by \$1,500.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above "Whereas" statements are adopted as a finding of fact.
2. The revenue and expenditure budgets of the Solid Waste Department shall be adjusted to account for unanticipated funds from KFB in the amount of \$1,500.00 for Fiscal Year 1999-2000.


