RESOLUTION NO. 2001- 111

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING THE DEDICATION OF LANDS AS COUNTY MAINTAINED PUBLIC LANDS FOR USE AS COUNTY ROADS AND PARKS.

WHEREAS, St. Johns County has the opportunity to build a public service Gazebo and nature boardwalk on the lands described in Exhibit "A" and Exhibit "B", attached hereto and incorporated by reference and made a part hereof; and

WHEREAS, the plat of Vilano Beach Unit A found in St. Johns County Map Book 4, page 48 and Unit "A" of Surfside Subdivision found in St. Johns County Map Book 4, page 32, establishes the lands described in Exhibit "A" and Exhibit "B" as public lands.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

1. The County accepts the dedication of lands described in Exhibit "A" and Exhibit "B" as County maintained public lands for use as County roads and parks and finds that such use is not detrimental to use of lots in Vilano Beach Unit A or Unit A of Surfside subdivisions for business and residential purposes.

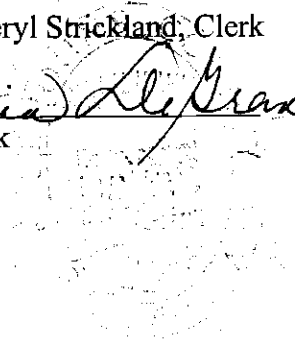

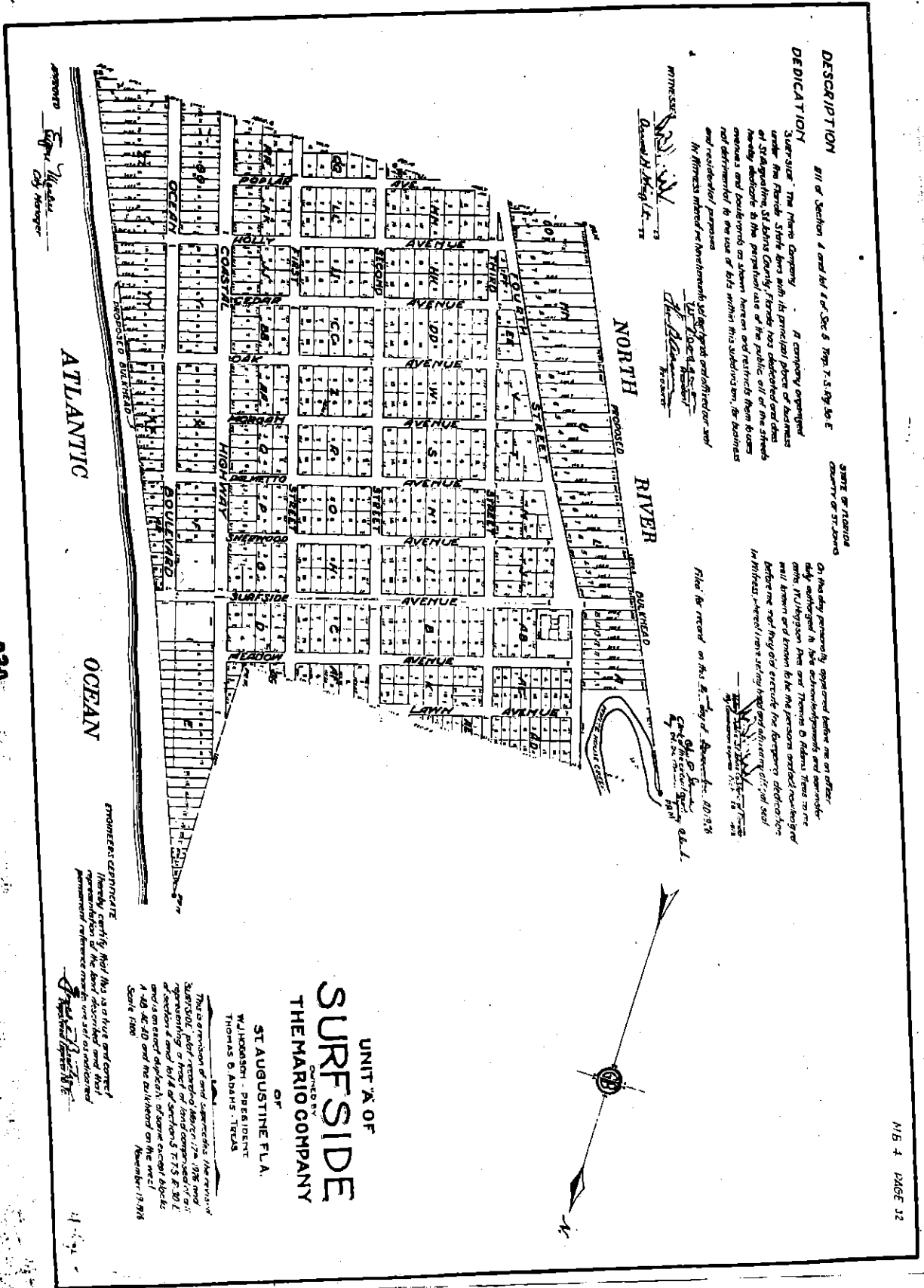
