

RESOLUTION 2001 - 149

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AMENDING THE FISCAL YEAR 2001 CAPITAL IMPROVEMENT PROGRAM FOR THE PROJECT OF "SHELTERS AT VILANO ROAD". CHANGING THE TITLE AND SCOPE OF THE PROJECT TO THE "GREENWAY/BOARDWALK AT VILANO ROAD". FUNDING AMOUNT AND SOURCE TO REMAIN THE SAME.

WHEREAS St. Johns County was awarded "Waterfronts Florida" status and received planning grants for a revitalization project at Vilano Beach; and,

WHEREAS the County Planning Department has received several state grants to assist in this revitalization effort that include landscaping/beautification, shelters with public restrooms, and a pedestrian boardwalk linking the Northshore community with the Town Center on Vilano Road; and,

WHEREAS these grants require local matching funds and in-kind services; and,

WHEREAS the County Recreation and Parks Department has allocated Tourist Development funds to assist as local matching funds for these projects; and,

WHEREAS the current Capital Improvement Project for these efforts incorrectly identifies the "Shelters at Vilano Road" as the initial grant project; and,

WHEREAS the "Greenway Boardwalk" grant project is in fact the initial project to be completed before October 1, 2001 and requires local matching funds,

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA that the fiscal year 2001 Capital Improvement Program be amended to change the name of the project from "Shelters at Vilano Road" to "Greenway/Boardwalk at Vilano Road". Account number, funding amount and funding source to remain unchanged.
