

RESOLUTION 2001 - 215

A RESOLUTION OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA, AMENDING THE FISCAL YEAR 2002-2006 CAPITAL IMPROVEMENT PROGRAM TO INCLUDE A PROJECT FOR THE CONSTRUCTION OF SPORTS LIGHTING FOR BALLFIELD #1 AT MILLS FIELDS PARK FROM THE RESERVES FOR IMPACT FEES ZONE "A".

WHEREAS, ballfield number one (1) at Mills Field Park contains older sports lighting and older wooden poles, and

WHEREAS, for playability reasons these poles and lights must be replaced with prestressed concrete poles and lights capable of sustaining 50 footcandles on the infield and 30 footcandles on the outfield, and

WHEREAS, sufficient funding for this project exists from reserves in Impact Fee Zone "A", and

WHEREAS, the estimated cost of replacing the poles and lights is about \$68,000, and

WHEREAS, the Creeks Athletic Association has committed to assisting in the cost of construction both in materials and labor, and

WHEREAS, the current Fiscal Year 2002-2006 Capital Improvement Program will need to be amended to include this project,

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA that the Fiscal Year 2002 – 2006 Capital Improvement Program be amended to include a project for the lighting of ballfield number one (1) at Mills Field Park.
