RESOLUTION NO. 2002-42

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING TRANSFER OF CERTAIN COUNTY OWNED PROPERTY TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR WIDENING IMPROVEMENTS TO STATE ROAD 207.

RECITALS

WHEREAS, the State of Florida Department of Transportation proposes to construct and improve State Road No. 207, Section No. 78050-20531 in St. Johns County, Florida; and

WHEREAS, it is necessary that certain land owned by St. Johns County be acquired by the State of Florida Department of Transportation for said improvements; and

WHEREAS, the State of Florida Department of Transportation has made an application to St. Johns County to execute and deliver to the State of Florida Department of Transportation a County Deed in favor of the State of Florida Department of Transportation, conveying all rights, title and interest that said County has in and to the said land required for transportation purposes; and

WHEREAS, said property is not needed for County purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above recitals are hereby determined findings of fact.

Section 2. The application of the State of Florida Department of Transportation for this conveyance is for transportation purposes, which are in the public or community interest and for public welfare, and the land is needed for transportation and other purposes and is not needed for County purposes.

Section 3. The County Deed in favor of the State of Florida Department of Transportation for consideration of \$1.00, conveys all rights, title and interest of St. Johns County, without warranty of title or warranty of method of conveyance, attached hereto as Exhibit "A", and Donation of Property attached hereto as Exhibit "B", shall be executed by the Chairman of the Board of County Commissioners.

Section 4. The County Deed transferring the property to the State of Florida Department of Transportation, attached hereto as Exhibit "A", shall be duly recorded in the Official Records of St. Johns County, Florida and a certified copy of this Resolution shall be forwarded forthwith to the State of Florida Department of Transportation, P.O. Box 1089, Lake City, Florida, 32056-1089.




