A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING TRANSFER OF CERTAIN COUNTY OWNED RIGHT-OF-WAYS TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE IMPROVEMENTS TO STATE ROAD NO. 207.

WHEREAS, the State of Florida Department of Transportation proposes to construct and improve State Road No. 207, Section No. 78050-2527, in St. Johns County, Florida; and

WHEREAS, said property is not needed for County purposes, and

WHEREAS, the State of Florida Department of Transportation has made an application to St. Johns County to execute and deliver to the State of Florida Department of Transportation a County Deed in favor of the State of Florida Department of Transportation, conveying all rights, title and interest that said County has in and to the said lands required for transportation purposes.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The application of the State of Florida Department of Transportation for this conveyance is for transportation purposes, which are in the public or community interest and for public welfare. The Subject Property is not needed for County purposes.

Section 2. The County Deed, attached herein as Exhibit "A", in favor of the State of Florida Department of Transportation conveys all rights, title and interest of St. Johns County, without warranty of title or warranty of method of conveyance, in and to the land described thereon for transportation and other road purposes, shall be executed by the Chairman of the Board of County Commissioners. Consideration shall be \$10.00.

Section 3. A certified copy of this Resolution shall be forwarded forthwith to the State of Florida Department of Transportation, Post Office Box 1089, Lake City, Florida, 32056-1089.

Section 4. The County Deed transferring the property to the State of Florida Department of Transportation shall be duly recorded in the Official Records of St. Johns County, Florida.
