**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA  
CHANGING A ROAD NAME FROM PETTY ESTATES RD TO RIVER  
VIEW RANCH RD**

WHEREAS, an application has been duly made to the Board of County Commissioners to change a road name from PETTY ESTATES RD to RIVER VIEW RANCH RD.

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows:

Section 1. The petition to change a road name from PETTY ESTATES RD to RIVER VIEW RANCH RD is hereby granted and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to change the named street and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.

SUBJECT: STREET NAME CHANGE

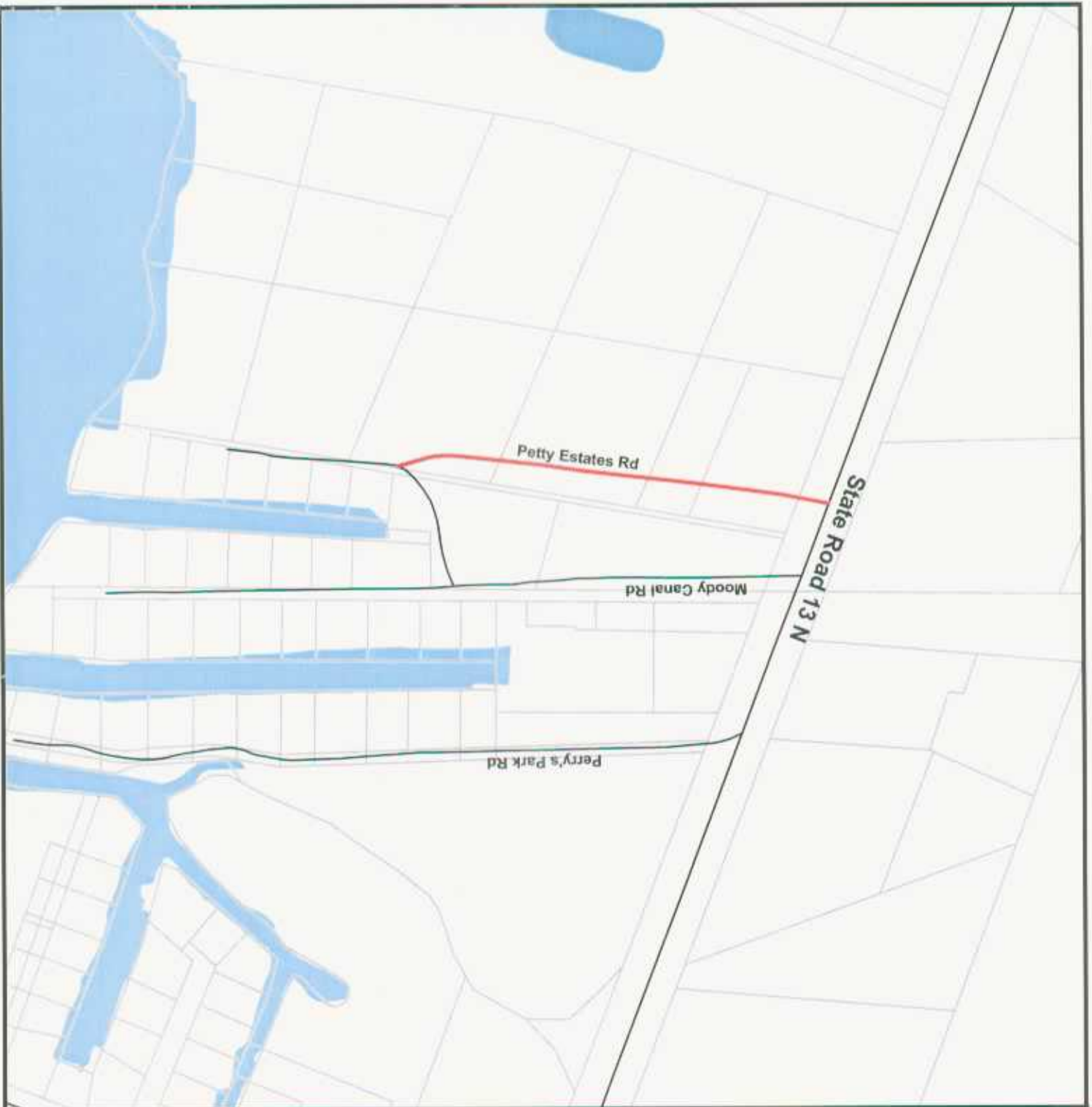

Thank you for your cooperation in this matter.

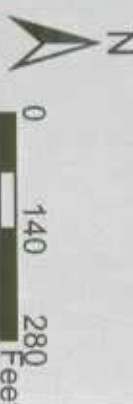
