**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA  
CHANGING A ROAD NAME FROM TRAIL ROAD TO LYNHALLA  
LANE**

WHEREAS, an application has been duly made to the Board of County Commissioners to change a road name from Trail Rd to Lynhalla Lane

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows:

Section 1. The petition to change a road name from Trail Rd to Lynhalla Lane is hereby granted and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to change a named street and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.
