A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE TERMS AND EXECUTION OF LICENSE AGREEMENT **AUTHORIZING** \mathbf{A} TEMPORARY USE OF RIGHT OF WAYS WITHIN PINECREST AND SURFSIDE SUBDIVISIONS.

RECITALS

WHEREAS, PS Partnership, have executed and delivered to the County a License Agreement, attached hereto as Exhibit "A", incorporated by reference and made a part hereof, for temporary use of right-of-ways within Pinecrest and Surfside Subdivisions; and

WHEREAS, PS Partnership have requested this License Agreement for the temporary use of certain roadways to facilitate the permitting/construction of roads, retention ponds, and other improvements within the designated subdivisions; and

WHEREAS, said License Agreement is for a period of six months commencing on the date the agreement is executed; and

WHEREAS, PS Partnership will allow the continuance of any use or access by the public and the County that have become customary in this area.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The BCC hereby approves the terms of the License Agreement and authorizes the County Administrator to execute said Agreement.

Section 3. The Clerk is instructed to record the original License Agreement in the Official Records of St. Johns County, Florida.

LICENSE AGREEMENT

THIS LICENSE AGREEMENT, made and executed this ____ day of March, 2003, by and between St. Johns County, a body politic, whose address is 4020 Lewis Speedway, St. Augustine, Florida 32095, hereinafter referred to as the "County," and PS PARTNERSHIP, a Florida General Partnership, hereinafter referred to as "PS."

WHEREAS, PS has requested this temporary license authorizing the use of certain roadways within Pinecrest and Surfside Subdivisions to facilitate the permitting/construction of roads, retention ponds, and other improvements within the designated subdivisions; and

WHEREAS, in consideration of the respective agreements of the parties herein contained, the County does hereby grant a revocable license without warranty, to PS, the temporary use of the roadways as described on Exhibit "A" attached for the purpose mentioned above.

- 1. To use above described Premises for a term of six (6) months, commencing on the date first above written and PS paying a nominal fee of \$100.00 per year (prorated).
- 2. PS may enter and use the subject Premises for the intended improvements. PS shall pursue a replat of the Premises and surrounding property. The Licensee shall be non-exclusive and PS will allow the continuance of any use or access by the general public and the County which have become customary on the Premises. Moreover, PS agrees to allow the County to grant any easement it deems appropriate during the period of this License that burdens the same Premises, so long as such easement does not substantially prevent PS's intended use of the Premises. PS agrees to, at all times, maintain access to Lots 4 6, Block 8 of the Pinecrest Estates Plat, recorded in Map Book 3, Page 144, by means of a right of access over PS's property.
- 3. All parties acknowledge and agree that any Board of County Commissioners of St. Johns County (hereinafter "Board") action necessary or contemplated by this License Agreement is subject to official action by the Board and compliance with federal, state and local law, including but not limited to, Chapter 125, Florida Statutes.
- 4. PS shall restore the Premises to its original condition upon revocation, destruction or termination or expiration of this License, unless PS subsequently obtains ownership of the Premises either through vacation of the roadways or otherwise.
- 5. PS shall make no improvements to, or maintain the property, or rely on the use of this Premises in any way which would make this License irrevocable. PS specifically hereby waives any argument or claim that this License is irrevocable.

- 6. PS shall not be permitted to make or suffer any waste or unlawful, improper or offensive use of Premises.
- 7. The County and its agents, servants, and employees shall have and hereby reserve their right and privilege, at reasonable times during the term of this License, to enter said Premises, to examine and inspect the same. PS shall not cause or permit any use of the Premises for other than those uses specifically provided for in this License.
- 8. PS, in consideration for the use of the Premises does hereby release and discharge and further will indemnify and save harmless the County from any and all claims for personal injuries or property damages during the existence of this License, arising in any manner by virtue of the use or occupancy of such Premises by PS, that PS does hereby further agree to indemnify and save harmless the County from liability for damage, injury or death to any person or persons arising out of the use of said property, or from the lack of keeping same in good repair and order, or from the negligent operation of same, or for any other cause for any nature whatsoever, provided such damage, injury or death is not due to County's own negligence.
- 9. PS shall conform to and comply with all laws, orders and regulations of the federal, state, county and municipal governments and all of their departments and bureaus.
- 10. The County may terminate this License upon a 30 day notice in writing.
- 11. The waiver of County of any such breach hereof on the part of PS, at any time or from time to time shall not be deemed, held, or construed as a waiver of any subsequent breach, or imply any further indulgence.
- 12. Notwithstanding any other provision of this License, PS hereby releases any rights it has in regards to the coupling of this License with an interest, thus hereby allowing the County to revoke this License on thirty (30) days written notice to PS for any reason whatsoever, without further liability between the parties except as expressly and specifically provided for in this License. The reasons for such cancellation may include, but are not limited to, increased public demand for use of the subject property and/or disaster relief use of space.
- 13. PS reserves the right to terminate this License by giving the County a thirty (30) day notice in writing.
- 14. The execution of this License Agreement shall not constitute a waiver by either party hereto of any right or claim of right to the subject lands or to use the subject lands.
