A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, STATE OF FLORIDA, MODIFYING THE MARSHALL CREEK DRI DEVELOPMENT ORDER AS PREVIOUSLY APPROVED BY ST. JOHNS COUNTY ON OCTOBER 13, 1998, UNDER RESOLUTION 98-91 AND AS PREVISOULY MODIFIED BY RESOLUTION 98-220 APPROVED DECEMBER 10, 1998; AND RESOLUTION 2002-103 APPROVED JUNE 4, 2002; AND RESOLUTION 2004-24 APPROVED JANUARY 27, 2004; FINDING THE MODIFICATION DOES NOT CONSTITUTE A SUBSTANTIAL DEVIATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Marshall Creek, Ltd. has submitted a Notice of Proposed Change (NOPC) to the Marshall Creek Development of Regional Impact (DRI) by letter dated April 23, 2004, requesting modification of Development Order Exhibit 2, Master Plan Map H to reflect adherence to Special Condition 36 of the Development Order (the "Notice of Change"); and

WHEREAS, the Developer submits that the change proposed in the NOPC does not constitute a substantial deviation pursuant to the terms of Section 380.06(19) of the Florida Statutes and the Developer has provided evidence that such change does not constitute a substantial deviation under any provision of Section 380.06(19) of the Florida Statutes; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

- 1. The following facts and conclusions of law are established by clear and convincing evidence to support this Resolution:
 - A. The requested change does not constitute a substantial deviation pursuant to the terms of Section 380.06(19) of the Florida Statutes because there is no change in either the number of development rights or increase in impacts from those approved in the original Marshall Creek DRI Development Order as amended prior to this change.
 - B. The change requested in the NOPC is consistent with the Land Development Code of St. Johns County, as amended.
 - C. The change requested in the NOPC is consistent with and furthers the objectives of the St. Johns County Comprehensive Plan 2015.
- 2. The Marshall Creek DRI Development Order Exhibit 2, Master Plan Map H is hereby modified by approval of the following specific changes:
 - A. Notation of Archeological Preservation Site (Site 8SJ3476) at the project's entryway from U.S. Highway 1.

- B. Notation of the April 8, 2004 revision date in the lower right corner.
- 3. Except as modified by this Resolution, the existing Marshall Creek DRI Development Order shall remain in full force and effect.
- 4. A certified copy of this Resolution, complete with all exhibits, shall be rendered by St. Johns County within ten (10) days of its adoption by certified mail, return receipt requested to the Developer, the Florida Department of Community Affairs, and the Northeast Florida Regional Council.
- 5. This Resolution shall take effect upon its adoption.





Dear Mr. Gaske,

In 1997, SEARCH documented the King's Road (8SJ3476) on the Palencia/Marshall Creek DRI property. A Mitigation Plan was sent to your office and was accepted in a letter dated July 6, 1999 (DHR No. 993805, Attachment A). The mitigation was to include "measured drawings and photographs of the roadbed, additional historic research, and preservation of a portion of the roadbed (50 to 75 feet) where the proposed Marshall Creek entry road will bisect the historic roadbed...... In addition, a historic marker will be erected designating the historic road and discussing its significance." The measured drawing, photographs, and additional historic research were completed as part of HABS/HAER Level 2 documentation of the road in 1999 and forwarded to your office for review. In a letter dated April 11, 2000 (DHR No. 2000-02345, Attachment B), your office agreed that the Level 2 documentation was complete and sufficient.

Palencia has since constructed the entry road and chosen a location where the King's Road crosses the entry road for placement of the historic marker (Attachment C). The proposed text of the marker is attached (Attachment D). Some minor variations to this text may need to be made based on space requirements. The following page contains a photo of the entry road showing where it bisects King's Road (Attachment E). Approximately 91 feet of King's Road is preserved within the entry road median. We are providing this information to advise you that once the marker is installed, we have met the terms of the mitigation agreement. We appreciate all of the input you have given us on managing the important cultural resources present at Palencia.



Location of the historic marker for King's Road and 91 foot preservation area on the Palencia/Marshall Creek DRI Property.


ATTACHMENT D TEXT FOR KING'S ROAD HISTORIC MARKER

Text for Historic Marker at King's Road

The historic King's Road intersects the entry road into Palencia at this point. If you look to the south, you may be able to see remnants of the elevated road bed and ditches on either side. King's Road was built between 1772 and 1775 by the British after they took possession of Florida as a way to encourage settlement into this area. The road extended from St. Augustine north to St. Mary's, Georgia, and south to New Smyrna where it linked with Andrew Turnbull's Minorcan colony. King's Road was the first road in Florida that was wide enough to accommodate wheeled vehicles. Where it crossed low, swampy areas, pine logs were laid crosswise and ditches cut to drain the area so the carts and draft animals would not bog down. Wooden bridges were built across creeks and wetlands. When the American Colonies declared independence from England in 1776, approximately 7000 Loyalists fled to Florida via this route to seek asylum rather than declare their loyalty to the Revolutionary cause. During the Second Spanish period (1784-1821), the King's Road fell into disrepair. When Florida became part of the United States in 1821, King's Road was improved. Later, during the early 20th century, oyster shell was added to the road bed, and after World War I, some areas were paved with red brick. Presently, sections of the original King's Road have been incorporated into modern roads, particularly US 1, are used as trails, or are abandoned such as the section you see here.

The historic marker will be placed approximately where the small white information box is, but on the south side of the entry road. The photo is facing south, taken from the exit side of the Entry Road on April 16, 2004.


