

RESOLUTION NO. 2004-210

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, DECLARING THE FURNISHINGS AND EQUIPMENT LOCATED IN THE STATE ATTORNEY AND PUBLIC DEFENDER'S OFFICE AS SURPLUS PROPERTY AND AUTHORIZING THE TRANSFER OF THE FURNISHINGS AND EQUIPMENT TO THE STATE OF FLORIDA PURSUANT TO SECTION 29.008, FLORIDA STATUTE.

WHEREAS, Section 45 of HB 0113A, Laws of Florida 2003-402 added Section 29.008 to Florida Statute which requires the county to donate the furnishings and equipment used by the State Attorney and Public Defender's office to the State of Florida.


AND WHEREAS, Section 274.05, Florida Statutes requires the approval of the Board of County Commissioners to transfer county property to state and local governments,

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida as follows:

1. The above recitals are incorporated into the body of this Resolution and said recitals are adopted as findings of fact.
2. The County property, as described in Exhibit "A", is hereby declared surplus property.
3. The Clerk of Court is directed to prepare and execute the necessary documents to transfer the automobiles and titles to the State of Florida.
