BIRD, 100SO.2D57 (FLA.1958)

RECITALS

WHEREAS, Resolution No. 2004-31 authorized the filing of a survey map of Winifred Masters Road claiming a vested interest in St. Johns County prescriptive rights of the public per case law Downing vs. Bird, 100so.2d57 (Fla. 1958) and under Section 95.361, Florida Statutes; and

WHEREAS, it has come to the County's attention that the survey map filed in County Road Plat Book 1, page 82 with said Resolution recorded in Official Records Book 2135, page 1960 showed the incorrect right-of-way width that the County has been maintaining; and

WHEREAS, the survey map has been amended to include the correct right-way-width and is attached hereto as Exhibit "A", incorporated by reference and made a part hereof; and

WHEREAS, by virtue of filing the amended survey map the right-of-width will be vested in St. Johns County.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The Chair of the Board of County Commissioners, and Clerk of the Courts are hereby authorized to file the attached Survey Map of Winifred Masters Road in the Public Records of St. Johns County, Florida.
- Section 3. The Clerk is instructed to record this Resolution in the Public Records of St. Johns County, Florida.


